(Continued from Page 1) acres in the Torrance field containing an estimated 327,500 barrels of oil. Engineer Luckett estimates that another 700,000 barrels should be recoverable on the Perry lease by secondary methods.

Four producing wells — the White No. 1, the Boer No. 1, the Riley No. 1, and the McCaffrey No. 5 are situated on this lease. Perry yesterday announced his intention to deepen 12 existing shallow wells in this area to the 5300 foot zone, moving his rigs every five days. Ten more shallow holes will be deepened later, drilling through the old casings.

Reaseachers Address Writers

Two sides to research in writing were presented by Los Angeles Times Reporter Charles Hillinger and Redondo Beach City Librarian John Perkins at a meeting of South-west Manuscripters last Friday night at Clark Stadium, 861 Valley Dr., Hermosa Beach.

Author of the new reference book on the eight channel islands, "The California Islands," Hillinger described the value to an author of gathering his own firsthand information in his talk titled "Logwork in Research."

Prior to actual "logwork" Hillinger suggested that writers avail themselves of newspaper libraries to obtain the names of people to interview and places to visit in connection with the planned article.

In his talk on the subject "The Library in Research," Perkins discussed a number of unusual books of aid to the writer including "The Modern Researcher" by Barzun and Graft, "Ayer and Son's Directory" to newspapers and periodicals which goes so far as to list editors' political affiliations, and "Literary Market Place, Directory for Publishers, Broadcasters and Advertisers."

(Continued from Page 1) 238th St., who was operating the equipment on the job, was ready to hoist the pair on the cable when the cavin occurred. He called to fellow workers nearby while City Plumbing Inspector Art Moore, who was on the job inspecting it at the time, ran to call for help. Watkins, associated with Ravin, in the construction company, then jumped into the hole and started digging.

Several hundred people gathered at the scene to witness the frantic struggle to free the trapped men. Police were forced to close down Hawthorne Blvd. for nearly an hour, creating a traffic congestion on several nearby residential streets.

THE CROWD around the excavation cheered as Dodge was brought out first, suffering from shock. He was rushed to the hospital for treatment before Ravin was brought out.

Ravin, who said he had been buried before, shrugged off the rope and harness firemen passed into the hole, and came out under his own power. He was reluctant to lie on the ambulance stretcher waiting for him at the top of the pit, saying he'd be all right "after I have a couple of shots of bourbon."

HE EMBRACED his associate, Watkins, thanking him for his help in the rescue. He was checked at the scene by a physician who had been standing by, and then rushed to the hospital. He was home shortly after suppertime.
