Garden Checklist

- 1. Keep a sharp eye to watering hanging baskets. With nothing between the roots and the drying effect of air and sun but the container, these can take water every day.
2. Stake and tie Delphinium plants. Nothing detracts from these beauties faster than broken stalks and drooping flower spikes.
3. Thin seedling vegetables. Check the recommendations on the seed packets and follow them.
4. Potted herbs, already started, are available in nurseries. They should be shifted to larger pots as they increase in size.
5. Keep planting Dahlias for succession of bloom. The same goes for Gladiolus which can be set out now for bloom in late summer.
