

New School Near Grandview To Be Ready in September

A new elementary school adjoining Grandview Palos Verdes is scheduled to start serving residents of the executive style community on the Palos Verdes peninsula next September, according to Sales Director William C. Kulow.

Construction of the \$850,000 school - Monte Malaga - will start within a few weeks on a site at the intersection of Via Nogales and Via Visalia, Kolow said.
