





Garrett Corp. Dividend Set At 50 Cents

The board of directors of the Garrett Corp., following its annual meeting of stockholders, today declared a quarterly dividend of 50 cents per share payable Dec. 31, to stockholders of record Dec. 12, 1960, it was announced today by J. C. Garrett, president.

At the same time he told the stockholders he predicted that despite a slow start the current year would be as good or better than last year's record sales of \$223,824,326 and earnings of \$5,776,584, or \$5.42 per share.

DURING THE annual meeting the stockholders voted to establish an Employee Stock Option Plan under which restricted stock options may be granted to officers and other key employees of The Garrett Corp.

The Garrett Corp., leader in support systems of space flight, missiles, aircraft and the diesel industry, operates through eight divisions and two wholly owned subsidiary companies in Los Angeles, Beverly Hills, San Francisco, Phoenix, Belmar, N.J., Toronto, Canada, and Geneva, Switzerland.
