**New Policy For Unwed Mothers
Announced by District Attorney**

Unmarried girls under 18 who apply for welfare assistance for the support of their children must first report the name of the father to police agencies for investigation, District Attorney William B. McKesson announced today.

Many of the cases are expected to result in charges being brought against the father for statutory rape or for sex delinquency, it was explained.

The action was taken after District Attorney's Office investigators reported "juvenile immorality is running unchecked and adding to the welfare roles which already support some 20,000 illegitimate children within this county alone."

The announcement by District Attorney McKesson was contained in a letter sent to all Los Angeles County local law enforcement agencies.

THE LETTER points out the Bureau of Investigation assumed county-wide investigative responsibility of criminal non-support cases on Jan. 3 of this year.

"The majority of these cases are referred as a result of an application for public assistance being filed on behalf of the child," it is explained.

"An alarming number of these cases involve unmarried girls under 18 years of age who are expecting or have given birth to a child."

THE LETTER went on to say that many of the parents of the young unwed mothers were themselves on relief rolls and failed to display normal concern over the plight of their daughters.

"Because of ignorance or disinterest these cases of statutory rape and sex delinquency are seldom if ever reported to police authority," it was charged.

Police officials throughout the county were advised that the District Attorney's Office from now on will require such reports to be made as an essential preliminary to a Failure to Provide investigation.

"THE RESULT will be that a minor girl expecting or having given birth to an illegitimate child will not be eligible for welfare assistance until the required report has been made."

Action by District Attorney McKesson to crack down on charity chiselers now results in an annual saving to taxpayers of more than \$3 million.
