

### Be Happy We Can Still Do Some Things for Ourselves--Chapel

You should be very thankful that the United States does not run everything from Washington, D. C., and that the State of California does not run everything from Sacramento. You believe in home rule, that is, letting the State or the United States do those things which the cities and counties can not do at all, or can not do as well.

People frequently forget the division of powers of government. For example, a lady in Westchester writes to me about the trash which accumulates in front of her house waiting for the City of Los Angeles to pick it up. I told her to write to Mayor Sam Yorty who is every interested in the rubbish problem. The State of California is not responsible for the trash problems of the City of Los Angeles.

A MAN IN Torrance, who lives in that part of Torrance represented by the Honorable Vincent Thomas, complained to me about the noise made by trucks hauling gravel from a gravel pit near his house. I told him that neither Assemblyman Thomas nor I have anything to do with his problem, that he should write to the City Manager of Torrance, the Mayor, and Members of the Torrance City Council. He agreed that this was a good idea.

People in Inglewood, Lennox, Westchester, Playa del Rey, and El Segundo have written to me repeatedly about the noise made by jet aircraft. At my request, the Legislative Counsel of the State of California conducted legal research and gave me two legal opinions on the subject about two years ago.

THEIR ADVICE was that the United States is responsible, hence people should write to their Congressman and their two U.S. Senators from California. However, one of the legal opinions I received from Sacramento said that in theory people annoyed by jet aircraft noise have a right to go into court and ask for an injunction, damages, etc.

Unfortunately, this would cost a vast amount of money and even if the people won in the lower court, they would find that the opposition would carry the case on appeal to higher courts, thus costing the people more money, and dragging out the case for many years. It must be admitted, however, that many portions of Inglewood, Lennox, Westchester, Playa del Rey, and El Segundo are not affected by jet aircraft noise, hence this should not scare away any prospective purchasers of property there.

PLEASE CHANGE your records to show that my new address is Post Office Box 327, Redondo Beach, and no longer Post Office Box 777, Inglewood 5. I am still paying rent on the Post Office Box in Inglewood, but it would save me a vast amount of time, gasoline and automobile maintenance if people would please use the new address.

You can receive free, from the Legislative Bill Room, Room 215, State Capitol, Sacramento 14, California, one copy of a paper-bound book titled: Summary Digest of Statutes Enacted and Proposed Constitutional Amendments Submitted to the Electors Including Table of Sections Affected, California Legislature, 1961 Regular Session. You can get one copy per person as long as the supply lasts. When all copies are distributed there will be more printed. Please do not ask me for a copy because I have only one. Please write to the Legislative Bill Room.

WHEN YOU get the book, find the laws in which you are interested and then write to the Legislative Bill Room, giving the Assembly or Senate number of the bill, the Chapter number, and the name of the author, just as it appears in the "Summary Digest." You can get two free copies of a law. Again, I must remind you that I do not have a supply of bills or laws on hand because if I did, I would have to rent a warehouse.

When you get your two free copies, if you have any questions about a law, write to me at Post Office Box 327, Redondo Beach, enclose one of the laws and list your questions. I shall then write to the Legislative Counsel in Sacramento and within two or three weeks I shall have your answer if it pertains to interpretation of the law. We have records of how people voted in the Assembly and Senate on bills, but we do not have records of actions by the committees of the two houses.
