DOPE CHARGE JAILS AREA MAN

Crashes Car Into Another Before Arrest

A 25-year-old Lomita man was jailed in Redondo Beach Friday on suspicion of driving under the influence of a drug. Police in the beach city arrested Donald A. Phillips of 24814 Woodward Ave. at the scene of an accident.

Redondo investigators said Phillips' auto crashed into one owned by William P. Stout of 210 N. Prospect Ave., Redondo. The Stout auto was parked on the street at the time of the accident.

The Lomita man was booked on suspicion of violating a section of the state's Health and Safety Code which makes it illegal to drive while under the influence of a narcotic. Phillips reportedly told officers he had fallen asleep.

Council To Review Zone Case

Councilmen will take a third look at two proposals for apartment development in the area of 230th Street and Madison Street when it meets at 8 p.m. Tuesday.

Two weeks ago, Councilmen approved both cases, one for a variance and the second for a change of zone; but withdrew that approval last Tuesday at the request of Councilman Willys G. Blount, who was absent two weeks ago.

ANOTHER councilman, George Bradford, was absent last Tuesday, so the matter was put over until this week. Residents of the adjoining area have entered protests to the land use changes, stating that the heavy traffic such a development would generate would use the residential area for access to the larger nearby boulevards.

PETITIONS bearing 162 signatures were presented to councilmen last Tuesday, and more than two dozen persons attended the meeting to press their objections.

Reconsideration of the requests is scheduled before a full council Tuesday.

Other matters on Tuesday's agenda includes a request for variance to construct a 45-unit apartment at 3411 Artesia Blvd.; award of contract to relocate Carson Street in front of Torrance High School; recommendations for action in meeting drainage problems in Victor Precinct; and recommendations from the city traffic and lighting engineer.

AGREEMENTS between the city and the county for transfer of land on the civic center for construction of the new Superior Court complex have been drawn up and will be presented to the councilmen for approval.

Ordinances to be submitted included those for establishment of the positions of personnel director and senior airport attendant in the city, increasing the salary range for planning director, and one relating to delegation of authority in the event a top-level city position is vacant.

IN ADDITION to these, councilmen will be asked to study an ordinance proposal which would set up a \$1500 fund to be used by police officers in obtaining evidence in narcotics and similar cases. Not more than \$100 would be available to the police chief at any one time and all funds would have to be accounted for to the director of finance although their use would be confidential, according to the proposal.

Torrance Cars Crash, Woman Passenger Dies

Gerald Davis, 25, of Inglewood, passenger in a car driven by Garvie Gomboa Jr., 25, also of Inglewood, suffered major injuries Wednesday night when the vehicle turned over on Hawthorne Avenue south of Del Amo Boulevard. Fog limited visibility and Gomboa's vehicle collided with a street barricade.

Schmidt To Head Realtors

Installation of new officers by the Torrance-Lomita Board of Realtors has been scheduled for next Saturday evening. It was announced here yesterday by President Delbert Vaughn. Realtor Jack Schmidt will be installed to succeed Vaughn. Other new officers include George Hanback, vice president; Fred Hansen, secretary; and Alvin Grancell, treasurer. Directors for the coming year will be Hallie Crow, Henry (Hank) Mahler, R. D. (Bill) McEwen, Delmar Wright, Don Borden, Geneva Meara, Ken Miller, Bob Trujillo, and Vaughn.

The past year has been a big one for the local board, and was climaxed Wednesday evening with the preview showing of the new facilities at the board headquarters, 22833 Arlington Ave. Under the direction of building committee chairman Ken Peters, a 6,000-square-foot addition which can seat 685 persons has been added to the office. The main hall has 4800 square feet, and the balance includes a kitchen, restrooms, a foyer, and a library.

In addition, parking facilities cover more than 22,000 square feet. Working with Peters on the building committee were Lee Dawson, Hallie Crow, Bob Clayton, Charles Kastner, Geneva Meara, Le Roy Woodruff, Earl Conley, and Henry Mahler.

Members of the women's division of the board served sandwiches, coffee, cake, punch, and hors d'oeuvres as civic officials, realty leaders, and friends of the Torrance-Lomita Board inspected the new building Wednesday night.

A COLLISION of two cars, both driven by Torrance residents, resulted in the death of a passenger Thursday.

The accident occurred at 129th Street and Shoop Avenue in the Hawthorne area. Killed was Betty Myers, 50, of Lawndale, passenger in a car driven by Frank F. Deshler Jr., 56, of 18437 Amie St., Torrance. Driver of the other vehicle was Mrs. Melinda A. Morgan, 18, of 1605 W. 208th St., Torrance. Deshler's car was hit broadside by Mrs. Morgan's, according to the California Highway Patrol.

BEVERLY WINNIFRED Williams, 24, of 237 W. Irena, Redondo Beach, suffered injuries to her mouth and leg after her car was involved in a collision with one driven by Laura Cecilia Simpson, 42, of 215 S. Lucia Ave., Redondo Beach. The accident happened about 1:30 p.m. Wednesday at a private parking lot at 190th Street and Anza Avenue.

FOUR TEENAGERS were treated at Little Company of Mary Hospital Thursday after a one-car accident at Flower Avenue and Monterey Street. The vehicle was southbound on Flower Avenue and apparently continued on where Flower deadends at Monterey Street, police said.


Mrs. Harold Hogue, Redondo Beach: "I think we are always getting too divided these days. There is no point in dividing the state. If we're going to survive we should remain united."
