Pinhole Camera Best For Eclipse Says CMA

More than 5,000 Californians, most of them children, will suffer permanent eye damage watching the partial eclipse of the sun on July 20 unless precautions are taken, according to the California Medical Assn.

less spectacular way to view the eclipse, but it is the safest way to see it. The simplest camera can be made with a cardboard box. A nail hole should be made in one side and a white piece of paper pasted inside the box opposite the hole.

Duration of the eclipse will vary over the state. In Los Angeles County, the eclipse will begin at 12:56 p.m. and reach maximum at 2:02 p.m.

THE LENS of the eye focuses the sun's rays on the retina with much the same intensity and effect as a magnifying glass achieves in burning a hole in paper.

Even welders' goggles fail to screen all harmful rays, and may cause retinal burns if the exposure is too long.

THE PINHOLE camera is a simple device that allows the viewer to see the sun through a small hole in a box.
