Hepatitis Becoming Major Contagious Disease in U.S.

Hepatitis, a disease that affects the liver, has become one of the major contagious diseases in the United States during recent years.

The disease seems to occur in cycles, with a peak occurrence being reached every 5 to 10 years. For instance, over 53,000 cases were reported nationally in 1962, which was a decrease from the peak year of 1961 with 72,691 cases but was considerably higher than the 14,922 cases reported in 1957.

Occurrence of hepatitis within the jurisdiction of the Los Angeles County Health Department followed the national pattern though there was a slight increase in the number of cases in 1962 over 1961. In 1961, the peak year nationally, 1,412 cases of the disease with 15 deaths were recorded in this area as against 1,512 cases and 15 deaths in 1962.

THE ONLY known forms of hepatitis are infectious hepatitis, which is by far the most common type of the disease, and serum hepatitis. Serum hepatitis is transmitted only by hypodermic needles or syringes contaminated with the hepatitis organisms, or by the injection of contaminated blood or certain blood products.

It is infectious hepatitis that concerns health officials, however, because it spreads readily among people who have close contact with one another unless strict sanitary precautions are taken.

Scientific evidence seems to indicate that at least two viruses, probably more, or different strains of the same virus, are able to induce the illness of hepatitis. Until these viruses are identified and isolated no preventive vaccine can be developed.

SYMPTOMS of infectious hepatitis, which appear suddenly in from 10 days to six weeks after infection, include fever, headache, chilliness, aches and pains, loss of appetite, weakness and prostration, nausea, and enlargement and tenderness of the liver. Jaundice, a yellowing of the skin, may be a symptom but appears in only about half of the cases that occur.

As in typhoid fever, infectious hepatitis is spread chiefly from person to person, commonly through the fecal-oral route, which means that hands inadequately cleansed after toilet may transfer the infective agents to articles handled by other persons, or to food and drink. This is the reason the disease occurs more frequently among people who live in crowded, unsanitary conditions sometimes found in certain institutions or low income housing, or among children who are careless about personal hygiene.

As a matter of fact, the disease occurs in young, school-age children more frequently than among other age groups but is usually less severe than when it occurs in adults. Many cases are so slight as to pass unrecognized, which is probably the reason some adults appear to have a certain degree of immunity to the infection.

WHETHER in household or institution, certain contacts may be protected by the administration of gamma globulin in those cases where the physician thinks it advisable.

This substance affords protection against the disease for a few weeks or may lighten an attack should one occur.

Treatment of infectious hepatitis consists largely of bed rest and a well-balanced diet. Uneventful recovery after six to eight weeks is the usual course of the illness, though a number of patients require about three months, and in some cases even more.

Prevention of the spread of the disease depends on good community sanitation and a strict personal hygiene, with particular emphasis on the thorough washing of hands after going to the toilet.

Explosive outbreaks, due to contaminated water, milk, or food supplies are not unknown in this country but are rare in areas such as Los Angeles County where sanitation standards are high.
