COUNCIL MOVES AGAINST ABANDONED OIL DERRICKS

Ordinance Provides For Instant Removal

The first step toward ridding Torrance of hazardous abandoned oil derricks was taken Tuesday night when Mayor Nick Drale asked that the proper ordinance be drafted to eliminate the menace.

Because no adequate law existed, long-abandoned derricks continue to stand in the Torrance area, presenting fire hazards, sump hazards, and a menace to children.

Measures

Judging from recent discussions of the matter the ordinance will call for the following:

1) Tearing down of all derricks which have no visible pumping means and whose wells are sealed off, within 180 days of their abandonment;

2) posting of an adequate "performance bond" at the time a well is licensed, so that the city will have money for the removal of the derrick if necessary;

3) delegating definite authority as to who is to enforce the ordinance;

4) make the city responsible for the removal of the derricks if the person responsible cannot be determined.

The council action follows in the wake of a long-standing campaign against abandoned derricks waged by the Torrance Press and brought to the attention of the public again in recent weeks.

Severe Criticism

While the proposed ordinance will be directed primarily at abandoned derricks, wooden derricks as a whole came in for severe criticism.

"Every wooden derrick is unsafe," Councilman Victor Benstead declared.

Benstead's statement is supported by a recent article appearing in "Drilling" magazine, March 1954.

The derricks are called unsafe, "old fire hazards, unsightly skeletons that have been passed for the past 30 years..."



NO TAX INCREASE PLANNED

No tax increase has been planned for the coming year, but... The estimated budget submitted to the city council calls for the same \$1.15 tax rate per \$100 of assessed valuation as was the case last year.

Added to this tax figure are the bond costs incurred by local voters when they approved the parks and recreation and fire station bond issues last April. The bond fee amounts to four

COUNCIL BRIEFS

MORTUARY: Request for a variance to construct a mortuary at Engracia and Cravens will be considered next Tuesday night. Granting of the variance to the Halverson mortuary was recommended by the planning commission.

USE TAX: An ordinance (No. 699) calling for a use tax was tabled for two weeks for further study.

PARKING LOT: Expansion of the parking lot in back of the city hall for use of city vehicles was requested by City Manager George Stevens. The council will study the matter.

MOUNTED MOUNTIES: Police Chief Willard H. Haslam presented Mayor Nick Drale and the city with a framed photograph of Torrance mounted police. The picture and a trophy case will be placed in the city hall.

ARLINGTON AVENUE: A resolution was passed requesting financial aid from the county board of supervisors for the extension of Arlington avenue.

SEWER DISTRICT: A hearing on the Hollywood Riviera sewer district No. 1 will be held July 20. Total estimated cost of the assessment district was placed at \$228,353.90.


AIRPORT COMMISSION: Establishment of an airport commission was enacted by the city council Tuesday. Councilman Willys G. Blount was made chairman. Also appointed to the commission were Councilmen Victor Benstead and Mervin Schwab. Each of the four councilmen and the mayor will make one appointment.

PROTEST: The International Association of Fire Fighters protested the reduction in rank of Milton T. Langum. Langum, a member of the fire department, has asked for a civil service hearing. It has been charged that the demotion was discriminatory and unjust.

CITY MANAGER: A \$1000 salary increase was granted City Manager George Stevens by the unanimous vote of the city council.

Douglas Unveils Most Advanced Research Center

The newest and most advanced aircraft design center in the world was unveiled yesterday at the El Segundo plant of Douglas Aircraft. The center was built at a cost of two million dollars and designed for rooftop heliport operations.

Police Station, Pool, Civic Center Asked

All the signatures needed to call for a special bond election for a police station, civic center, and swimming pool were filed with the city clerk yesterday.

Such an election will be held in September or October provided the official approval of the signatures is given by the registrar of voters.

The drive for reconsidering the two bond issues so narrowly defeated in the last bond election was spearheaded by Mrs. Herma Tillim.

The petitions call for consideration of a \$700,000 bond issue for the Civic Center, to provide offices to replace the crowded conditions at City Hall, Police Department, and City Jail.

Pool

The second proposition which the petition requests be placed on the ballot is a swimming pool and bathhouse, which would cost about \$250,000.

In the April election, the Civic Center bond issue failed by 56 votes of receiving the necessary two-thirds majority. It received only 65.71 per cent of the votes. The swimming pool bond issue received 63.96 per cent approval, 159 votes short of adoption.

Mrs. Tillim said she was leading the drive for reconsideration of the proposals because of the urgent need for both fa-

Ambulance Service Provided

Obtaining ambulance service, guaranteed to handle all accident calls ordered by the Torrance police department, was approved by the city council last Tuesday night.

The need for a proper service which would be available to the police department without fail was stressed by Mayor Nick Drale several weeks ago. He asked that immediate steps be taken to contract for such service.

The Albert Taft ambulance service, which received the contract, will be paid by the patients. In case the money cannot be collected, the city will pay \$7 per call with a guaranteed monthly minimum and \$35 maximum.

Police Chief Willard Haslam considered this arrangement quite adequate. The reason why the Torrance police department
