\$50,000 Damage Suit Filed

Lloyd "Hap" Pick, formerly employed at Mor-Glo Paints in Torrance, has filed a \$50,000 civil damage suit against his former employer Herb Gleicke. The suit arises out of Pick's complaint that he was twice arrested on the same charge (forging a check and then again for stealing the money covered by the check). Attorney for Pick is Albert Isen. Pick was found innocent of the forgery charge in 1954 on the basis that he had permission from the customer to sign the check. A follow-up petty theft charge for the amount of the check was dropped. Gleicke has filed a counter-suit to the \$50,000 damage suit for \$2000 for inventory shortages and money due. Gleicke is being represented by Van Hagenbaugh. The matter went to court in Inglewood Superior Court Tuesday.
