

### Phone Co. Compromise Agreed To

A compromise solution worked out by the General Telephone Co., and representatives of the Planning Commission and Hollywood Riviera homeowners has been recommended for approval by the Planning Commission.

The recommendation involves the addition to the company's station at 650 Palms Verdes Blvd. The following conditions were mutually agreed to:

1. No ingress or egress, other than pedestrian, shall be made from an adjoining alley.
2. A six-foot masonry wall shall be built around the east, north, and south sides of the property.
3. Decorative or protective lights shall be put on the building so as not to be a nuisance to neighbors.
4. Nothing shall be placed above roof level.
5. The new building shall approximate the height of the old one.
6. All cable (except for local service) shall be placed underground.
7. No windows shall be put on the east, north, and south sides of the building.
8. Appropriate landscaping shall be put on all areas not needed for building or parking.
