Council To Get Plan

The City Council of Torrance will get a \$8,750,000 plan designed to rid the city of sumps, tomorrow night. And, according to John Patrick, city engineering assistant, the plan would include the draining of the Walteria Lake area.

The plan, according to Patrick, calls for 14 projects that would carry excess water from areas of the city subject to seasonal flooding.

The largest of the plans is the Walteria draining plan, which proposes to tunnel through a ridge to carry the waters of the inundated area to the ocean during the seasonal floods. The approximate cost of this project alone would be about \$4,000,000.

A request from the League of California Cities for a plan was made for possible presentation to the Board of Supervisors with an eye to proposing a bond issue for county wide flood improvement, Patrick said.

The county bond issue approved in 1952 provided about \$1,500,000 worth of drainage systems. This was less than half the amount requested by the city then.

The drainage system, if put into effect in the Walteria Lake region, would aid in the development of the area.

Action Expected For Next City Council Meet

A heavy turnout is expected at the City Council Meeting tomorrow night as the result of last Tuesday's stormy session between Mayor Pro Tem Robert Jahn and Councilman Willys Blount. And just what will develop is anybody's guess.

Councilman Blount, during discussion over the airport fuel dispensing problem, hurled charges that the "Official Family" was guilty of conflicting interests when important airport issues are at stake. He repeatedly said that he would prove the conflicting interests motives, "sometime in the future."

Observers at the Council meetings have indicated that Blount has made these charges and suggestions in the past. But, has yet to prove them.

Blount has said that the charges are not leveled at Jahn specifically, although it was apparent to most observers that Jahn was the target of Blount's attack.

The Mayor Pro Tem said that his interests "are with the City only." He added, "if Councilman Blount has something to show 'conflicting interests' on my part, then he better prove it."

Jahn told the Press that what appears to be a personality clash between the two officials can very well mar the Airport Bond issue in the eyes of the public. "The sort of thing Blount is doing is creating a dark cloud over the whole airport issue. Moreso since we all want it to pass."

CIVIL DEFENSE WEEK HERE IS SEPT. 18 to 24

The Civil Defense Administration of the City of Torrance announced today that the week of September 18th through 24th is Civil Defense Week.

During this time the Administration said that residents of Torrance should avail themselves of Civil Defense information. And this year, the latest information is available in a self explanatory brochure from the National Guard.

Guard Conducts Programs

The guard, it was learned, is conducting educational programs in Civil Defense for all organizations. They will accept appointments for these programs. Anyone interested should call Captain Horlander at the Guard Armory for further information. The county Disaster-Civil Defense Authority says the threat of enemy nuclear attack is as much with us today as it was a year ago, and the necessity for individual knowledge of self help practices which might save lives is obvious.

Legislation Effective

California legislation became effective September 11, 1957, providing authority for county boards of supervisors and city councils to designate alternates to serve should these officials be incapacitated or unavailable as a result of a disaster. This move was taken in the interest of assuring a continuity of governmental functions.

The need for governmental ability — governments on all levels — to survive and operate effectively under extreme emergency conditions is of paramount importance, the Defense Authority said, and man-made disasters and natural disasters are fundamentally alike. Basically, they can best be met by strengthening the organizations now in operation. This means that there is an urgent need for the individual citizen to support the Civil Defense program of (Continued on page 2)

Increased Water Use Here, Told

SACRAMENTO, September 16.—Use of imported Colorado river water in the West Coast Basin of Los Angeles county, which includes Torrance, increased 17 per cent during the 1956-57 season over the previous year.

This was revealed today by the California Department of Water Resources when it released its second annual report on water-master service to the West Coast Basin area.

Ground water extractions for the past year totalled 53,857 acre-feet, approximately the same as the previous year. The report also showed that overall water use in the area during the past year amounted to 185,519 acre-feet, or an increase of about 11 per cent over 1955-56.

They said the adoption of \$4,000,000 worth of bonds would cost the average family only \$4.50 annually.

City 'That Knows How' Hosts 'All-American City' Officials

Sixteen city officials from Torrance will journey to San Francisco next week for a meeting of 59th Annual Conference of the League of California Cities. The conference will extend from September 22 to the 25th.

Key Issues

"Where and how California's growing cities are going to get the future water supply needed for their ever increasing population, and how they will meet the challenge of growth inside and outside cities" will be two of the key subjects before the conference.

Ten new cities have been incorporated in 1957 in California, and 14 new cities were organized in 1956. Since 1950 a total of 40 new municipal incorporations have started functioning in California. A special discussion and instruction session for the officials of these new cities has been arranged for Sunday afternoon, September 22, preceding the regular business sessions beginning on Monday. Mayor Hoelis Peavey of Downey in Los Angeles County, with 90,000 people, the largest single community ever to incorporate, will be the presiding officer. F. Robert (Continued on page 2)

Coop, city manager of Fremont in Alameda County, which has an area of approximately 100 square miles, will be one of the consultants.

Advance Registration

Advance registrations indicate an attendance of approximately 3300 persons. At last year's conference in Los Angeles, there were 3062 Registered delegates and guests; in 1955 the attendance was 2736. There are now 348 incorporated cities in California and delegates will attend from at least 275 of them. All but two very small cities are members of the League.

RYAN READIES PLAN FOR ADDITIONAL CONSTRUCTION AS CITY WELCOMES FIRM

Tomorrow morning at 7:30 The City of Torrance will officially welcome the Ryan Aeronautical Company into the fold of Industry and Commerce in this area. However, even as plans are being formulated for the welcome, it was learned that Ryan was completing further plans for additional construction near their present site.

Burning Ban Deadline Set For October 1

On October 1, "Old Smokey," the backyard incinerator, will pass into the history of Los Angeles County as the burning ban deadline arrives, and the Air Pollution Control District begins immediate enforcement of the ban.

Thus residents of the unincorporated area not served by garbage disposal districts have just two more weeks in which to make arrangements for private collection of their combustible refuse. In order to prevent the accumulation of rubbish, it is necessary that these residents make arrangements with private collectors for service and payment therefor or haul it themselves to a lawful disposal facility.

The County Ordinance governing such collection by private contractors does not apply to residents of certain sections of unincorporated areas lying within garbage disposal districts. In these districts collection service for combustible rubbish as well as for garbage is already provided under a county contract, the costs of which are added to the property owner's tax bill.

Neither does the County collection Ordinance apply to householders living within any incorporated city.

The Board of Supervisors has placed the program under the watchful surveillance of the (Continued on Page 2)
