Griffin said, "with man's formidable array of technical skill he has been able to send rockets around the moon, take pictures of the other side of it; and hit a target with a rocket several thousands miles away. It seems

he has accomplished everything except what he desires most and that is to find peace in this troubled world. "The reason for man's failure," Griffin said "is that man has tried to apply his own remedies

Torrance Youth Band Slates Benefit Performance by Mormon Choir

The Torrance Area Youth Band will sponsor a benefit performance by the Mormon Choir of Southern California March 26 at Redondo Beach School auditorium. Proceeds will be used to purchase new uniforms for the band.

Since the earliest days of its history, the Church of Jesus Christ of Latter-day Saints has been engaged in pursuit of cultural arts.

Drama, dancing, public speaking, and music have been sources of entertainment and development for the Mormon people. Choral singing has been almost a trademark of Mormons with the Salt Lake Tabernacle Choir saluted as one of the great musical organizations in the world.

It was in this spirit of cultural development that the choir was organized six years ago. In that period it has grown from an idea to a well organized finely rehearsed musical group of 150 voices, recognized as one of the great choirs in the country.

With Frederick Davis as musical director, the choir has made over 70 national broadcasts, been featured on coast to coast television, appeared in the Hollywood Bowl, the Redlands Bowl, and the San Diego Fiesta del Pacifico.

The Mormon Choir annually presents Handel's "Messiah" at the Los Angeles Philharmonic Auditorium. From the proceeds of the two performances given in 1959, the choir donated \$25,000 to the Los Angeles Music Center building fund, and became the first group of its kind to be a founder member.

Davis brings to the 150-voice singing group a rich background of musical experience.

Shortly after his arrival in the United States from New Zealand in 1934, he became director of a singing group that performed throughout the nation. In 1936 he was appointed musical director of the Salt Lake Civic Opera Association.

With his Philharmonic Choir and Orchestra he gave Utah its first performances of such masterpieces as Beethoven's "Missa Solemnis," Verdi's "Requiem," and Bach's "Mass in B Minor."

In addition to conducting the Mormon Choir of Southern California, Davis also is conductor of the famous Ellis-Orpheus Male Chorus, and the Women's Lyric Club.

He is a member of the National Association of Teachers of Singing and the National Association for American Conductors and Composers. He is choral chairman of the board of the California Federation of Music Clubs, and also has served as a regional judge for the Metropolitan Opera auditions.

Healing Power of Prayer Told

Scientific prayer is bringing increasing numbers of people healing, comfort, and reformation. Richard L. Glendon of Los Angeles said in a public lecture here last Thursday.

During the course of his lecture entitled "Christian Science: The Healing Comforter," Glendon described healing of kidney stones and ulcers through wholly spiritual means.

He took as his keynote theme the Apostle James' promise, "Is any sick among you? let him call for the elders of the church; and let them pray over him, anointing him with oil in the name of the Lord; and the prayer of faith shall save the sick, and the Lord shall raise him up; and if he have committed sins, they shall be forgiven him" (5:14,15).


