Small Business

Loans increase. Noted in October. Donald McLarnan, regional director of the Los Angeles Administration, Small Business Administration, this week announced that 19 business loans for \$733,600 were approved during October, an increase over September in number of loans, when 15 business loans were approved.

On a cumulative basis, since the start of the SBA Financial Assistance Program in 1953, the Los Angeles regional office, comprising Southern California, the State of Arizona and Clark County, Nevada, has approved a total of 1683 loans for \$78,250,393.

In addition, one disaster loan for \$50,000 was approved in the Los Angeles region during October. On a cumulative basis, since 1953 there have been 135 disaster loans approved for \$1,419,613 in this region to owners of homes and businesses suffering damage from natural disasters.
