Temple Menorah Plans Dedication Ceremonies

A series of dedication events for Temple Menorah of the South Bay will take place Oct. 6, 7 and 8 at 1101 Camino Real, Redondo Beach, George L. Lewison, president of the reform congregation which serves members of the Jewish faith throughout the South Bay and Palos Verdes Peninsula areas, invites the public to attend.

Friday evening, the Sanctuary-Community Hall will be dedicated at religious services starting at 8:30 p.m. Rabbi Henri E. Front, spiritual leader of the congregation, announces that Dr. Morton Fierman will make the dedication address.

Fierman is Rabbi of Temple Beth Shalom of Santa Ana. Highlight of the dedication ceremony will be the affixing of a mezzuzah to the main door of the Sanctuary.

A mezzuzah is a small religious ornament which contains the watchword of the Jewish faith from Deuteronomy, Chapter 6, Verse 4, which declares the oneness of God. It is customary for Jewish homes to have a mezzuzah affixed to the doorpost.

Temple Menorah's new facilities consist of a Sanctuary-Community Hall, capable of seating 600 people, ten religious school classrooms, administrative offices, library, Rabbi's study, recreation room and kitchen.

A new ark, containing the sacred scrolls of Judaism was designed and made through the craftsmanship of Sydney Siegel and his son, Howard, temple members.

Religious Services are conducted each Friday night at 8:30 p.m. by Rabbi Front.

Cantor Harry Newman and the Temple Choir, directed and accompanied by Mrs. Harry Newman, sing the musical portions of the Service.

Sisterhood will contribute to the weekend's festivities with a dedication - dinner dance Saturday at the temple, starting at 7:30 p.m. Reservations may be made by calling Mmes. Henry Rappaport, FR 8-5136 or Arthur E. Heslov, FR 8-1772.

Sunday Ceremonies Sunday morning, bread, salt and sweets - usually brought to a new house - will be part of the classroom dedication ceremonies conducted by Rabbi Front. Also present will be Lewison, Mrs. David Goldenberg, chairman of the Religious School Committee, and Norman Horowitz, religious school principal.

Each class from kindergarten through tenth grade will dedicate its own room by affixing mezzuzahs to the classroom doors.

The religious school, which only six years ago numbered 50 children, now has a total enrollment of 350.

Mrs. Harry Komer, music director of the school, is responsible for teaching of music related to religious observances. She also directs the Children's Choir.

Religious School Temple Menorah's religious school is affiliated with the Los Angeles Bureau of Jewish Education and has an accredited teaching staff.

Young people who have completed the 10th grade and have been confirmed as teaching assistants.

Inside Your Home

Your Decorating Problems Answered

Mr. Wallace:

Should the lamps in a room match or can they be different in size and color? I was told by a decorator that lamps should match to give your room a continuous planned look. I don't agree with this and I would appreciate your comments on this.



Mrs. Chester Day, Torr. Mrs. Day: I must say I don't agree with this either in general, but there are always good reasons for matching lamps. It depends on the decor, the layout, the scale, and color of what ever else is going on in the room. For example in contemporary furnishings I suggest not matching identical lamps, transitional the same way, Colonial traditional and provincial are generally desirable with matching lamps. However remember I am speaking in general terms only, each situation and room requires a different analysis. I suggest you contact a qualified decorator for a complete analysis of your room problems.

Mr. Wallace:

I have been told by some of your clients that in decorating windows you like to use some type of double draperies. Would you please tell me how and why?

Mrs. J. T. Kolls, Torrance Mrs. Kolls: I never like to stereo anything, but on many occasions I have used a two track method of hanging draperies. In general I think that windows are not always beautiful to look at, therefore I suggest a sheer material on the inside track close to the window

and an over lay of material that will traverse over the sheer fabric for privacy. The sheer fabric should be of the same color density of the heavier fabric, but you should be able to very clearly see through the sheer panels, this is a very pleasing way of treating most all windows.

Here are a few tips on planning the color scheme of a room:

- 1. Consider the general color character to be expressed and decide which type of scheme is to be used.
2. Consider the amount of natural or artificial light to determine in general the tonal values of the main areas.
3. Obtain samples of all colors and materials and examine them in their natural light.
4. Keep all color schemes as simple as possible. Usually three different colors for the dominant and medium areas are sufficient.
