## Over One-Hundred Works of Art Featured at 'Futurism' Exhibit

Many of America's leading art collectors have lent works to the "Futurism" art exhibition opening at the Los Angeles County Museum recently and continuing through Feb. 25. There will be an admission fee for this first major art event of 1962 which commemorates the 30th anniversary of a revolutionary early 20th century Italian movement.

Among the more than 100 paintings, sculptures, drawings and watercolors comprising the show are three paintings from the private collection of Governor Nelson A. Rockefeller of New York. Other prominent American collectors represented in the exhibition include Mr. and Mrs. Harry Lewis Winston of Birmingham, Michigan, whose collection of Futurist art is world-renowned. Mr. and Mrs. Morton G. Neumann of Chicago and Mr. and Mrs. S. J. Zacks of Toronto.

The exhibition was originated by the Museum of Modern Art in New York and has just closed at the Detroit Institute of Arts. It is supplemented by 138 drawings by Boccioni from the collection of Mr. and Mrs. Harry Lewis Winston.

## Power Named to Dean's List for Penn's Fall Term

Among the 1,335 undergraduates at Pennsylvania State University named to the Dean's List for the Fall Term which ended in December, was Charles F. Power, 19308 Gatradero, Torrance.

The Dean's List requires an average of 3.50 or better. Power, a junior, maintained a 3.75 average.

A total of 1,335 undergraduates at the Pennsylvania State University were named to the Dean's List for the fall term. The total, a record number, is considerably higher than a year ago when 862 attained the honor.

Included in the 1,335 total are 219 students who attained perfect 4.00 averages for the fall term as compared to 93 who attained a perfect average a year ago.

The Dean's List included 1,218 undergraduates who are candidates for the baccalaureate degree, with 1,100 of them enrolled at University Park and 118 at the Commonwealth Campuses. There were 117 candidates for the associate degree, a two-year program offered at the various Commonwealth Campuses.

Dr. Robert G. Bernreuter, dean of admissions and registrar, attributed the continuing upswing in academic achievement to a variety of factors, including better preparation and better application.

He said students today are a more studious lot and he cited increased use of the library, quieter study hours, and less week-end travel as evidence of this trend.

He also noted that the student body today is better, pointing out that 65 per cent of the present freshmen came from the top fifth of their high school classes while ten years ago, only 38 per cent came from the top fifth.

## Reimbursement Funds Awarded to El Camino College Through Grant

to the amount of \$4,000 have been awarded to El Camino College under the provisions of the W. K. Kellogg Foundation grant to aid the college in the planned nursing program.

The support is destined to provide assistance to the college during the planning year for an associate in arts degree for nursing students. The new program is scheduled to begin the fall semester of 1962.

Application for the grant, submitted by ECC to the Coordinating Committee of the California Associated Arts

Nursing Project, was reviewed and passed this fall.

Completion of two academic years of study and two six-week summer courses will enable the nursing student to obtain an AA degree, under the provisions of the grant.

Students must take courses in basic sciences and in theory and practice of nursing. Non-nursing courses will balance the nursing classes to satisfy the requirements.

After graduation the student is eligible to qualify as a registered nurse.

## Schedule Street Light for North Carson District

Twelve streets in the Carson area my soon have street lights.

Supervisor Burton W. Chace said the County Board of Supervisors has scheduled a hearing for 9:30 a.m., Jan. 25, on the proposed annexation of Tract No. 25661 to County Lighting Maintenance District No. 1697. The hearing will be held in room 381 of the Hall of Administration.

"If the board approves the annexation after the hearing, 93 lights will be installed in the tract," Chace said.

He added that the hearing will give interested residents in the tract a chance to protest or support the annexation.

On Dec. 26, 1961 the board adopted a resolution of intention to annex the tract. The Southwood Construction Company requested the annexation and has already paid the Southern California Edison Company the cost of installing the steel poles. The Edison Company will install all of the lights with overhead wiring.

Tract No. 25661 is bordered by 190th St. on the north, Campaign Drive on the west, Elsmere Drive and Turmont St. on the south, and Annalee Ave. on the east. The tract's boundaries were approved by the County Boundary Commission on Nov. 15, 1961.


