Pot Shot was scheduled to include carrier strikes, anti-submarine operations, amphibious landings, replenishment at sea, mine warfare, naval convoy operations, Marine operations ashore and aerial, surface and sub-surface reconnaissance.

"The opportunity to bring together all these forces in a single operation is rare," says Vice Adm. Charles L. Melson, commander of the First Fleet and exercise commander. "We hope to considerably enhance the operational readiness and capabilities of all Pacific Fleet units participating."
