## Mile High Souffle Is Light

Capture the lightness of a bright day with a mile high lemon souffle topped with strawberries. Light in flavor and texture, the souffle is sure to stay high because it is made with a gelatin base and needs no baking.

When the ingredients are mixed, spoon the mixture into a souffle dish with a "collar" of waxed paper added to give the dramatic height. Simply remove the paper before serving.

The finishing touch for the dessert is a crown of strawberries, either fresh or frozen.

### MILE HIGH SOUFFLE

- 2 cups boiling water
- 2 pkgs. (3 oz. each) lemon-flavored gelatin
- 2 bottles (7 oz. each) lemon-lime beverage
- 1/4 cup lemon juice
- 1 tsp. grated lemon rind
- 1 pt. (2 cups) heavy cream, whipped
- Few drops yellow food coloring
- 1 pt. fresh strawberries, sweetened, or 1 pkg. (12 oz.) frozen strawberries, thawed

Four boiling water over lemon-flavored gelatin. Stir until dissolved. Stir in lemon-lime beverage, lemon juice and lemon rind. Chill until almost firm.

Beat gelatin until foamy. Fold in whipped cream and yellow food coloring.

Pour mixture into 1 1/2 qt. souffle dish or casserole until one inch from top of dish. Place a 3-inch collar of waxed paper around inside top of souffle dish.

To make waxed paper collar, cut a length of waxed paper long enough to circle dish. Fold waxed paper in fourths, lengthwise. Bring edges together to form a circle. Circle inside of dish with waxed paper collar so that it extends about 2 inches above top of dish.

Pour remaining lemon mixture into dish. Chill for several hours or until firm. Carefully remove waxed paper.

Serve chilled, with sweetened fresh or frozen strawberries. Makes 8 servings.

- 1 8 oz. can tomato sauce

Pan-fry bacon until crisp. Remove and drain on absorbent paper. Add potatoes and onion rings; fry until lightly browned. Heat tomato sauce in saucepan until very hot.

## THIS ORIENTAL CASSEROLE IS EASY ON COOK

### CASSEROLE A LA CHINOISE

- 1/2 medium onion, diced
- 1/2 cup diced green pepper
- 1 cup diced celery
- 1 1/2 tbs. butter
- 1 7-oz. can chunk tuna (chicken may be used)
- 1/2 pkg. frozen peas
- 1 cup processed rice
- 1 can cream of mushroom soup
- 1 1/2 cups water
- 1 tbs. Sona Soy sauce
- 1/4 cup chopped pecans

# New telephone rates to become effective

Pacific Telephone has filed with the California Public Utilities Commission lower rates for services to its customers within the State of California. The new rates, ordered by the Commission, will go into effect this month on an interim basis pending the fixing of final rates by the Commission at a later date.

For one-party residence service, the monthly basic charge will be 45 cents lower. For one-party business service, the monthly basic charge will be 70 cents lower. Other residence and business rates will also be less. These new basic monthly charges will appear on all customer bills dated on or after June 20.

Message units which are presently 4.25 cents each will be reduced to 4.05 cents. Starting June 10, message unit calls will be charged at the new rate.

New Long Distance rates between points in California also become effective June 10. Calls over 80 miles within California will cost five to 25 cents less for the first three minutes, depending on the distance and type of call. Some charges for additional time talked also will be less.

For example, weekday three-minute station-to-station calls between San Francisco and Los Angeles will go down from \$1.25 to \$1.20, plus 10% Federal tax.

In addition to reducing its rates, Pacific


Telephone will refund to its customers the difference between the new rates and the rates charged since July 20, 1964—the effective date of the rate reductions as ordered by the California Public Utilities Commission. These rates were held up pending a review of the order by The Supreme Court of California. The amount of the refund will include interest at the annual rate of 6%.

By July 1, a plan for refunding this money will be filed with the Public Utilities Commission. After approval by the Commission of a plan, we will notify our customers how and when the refund will be handled.
