



THEODORE BRUINSMA Joins Firm

Bruinsma Named to New Post
Packard Bell Electronics Corp. announced today that Theodore A. Bruinsma had joined the company in the newly created position of executive vice president.

Dr. Wendell B. Sell, president and chief executive officer, said the addition of the Bruinsma "materially strengthens our management group at a time when Packard Bell is entering a period of major growth."

SINCE 1961 Bruinsma has represented major corporations in financial planning and fiscal control, acquisitions, and mergers. Previously, he was president, owner, and chief executive officer of Systematics, Inc., an east coast electronics company; general counsel and secretary of McCall Corp.; and senior attorney with the Wall Street firm of Whitman, Ransom and Coulson, where he specialized in corporate finance, underwritings, and contract negotiations.

A graduate of Washington and Lee University, Bruinsma received his MBA from the Harvard Graduate School of Business and his LL.B. from Harvard Law School.

BRUINSMA is currently a director of Technical Industries and The Scionics Corp., and is a member of the American Bar Association, American Management Association, Young President's Organization, and Harvard Business School Association.

He has been prominent in civic activities in his native New Jersey and in Southern California since becoming a resident in 1961. He was the Republican candidate for Congress in the 17th Congressional District in 1962. He and his wife and four children reside in Rolling Hills.
