ORDINANCE NO. 1674
AN ORDINANCE OF THE CITY OF TORRANCE, CALIFORNIA, TO REPEAL SECTION 18.7 OF THE CODE OF THE CITY OF TORRANCE, 1954, AND SUBSTITUTING A REVISED SECTION 18.7 THEREFOR TO PROVIDE FOR REVOCATION, SUSPENSION, HEARING, NOTICE, IN RELATION TO OUTDOOR RESTAURANT PERMITS AND DECLARING THE PRESENCE OF AN EMERGENCY.

That Section 18.7 of Article LIII, Chapter 18, of "The Code of the City of Torrance, 1954" is hereby repealed in its entirety.

Section 2. That Section 18.766 of Article LIII, Chapter 18, of "The Code of the City of Torrance, 1954" is hereby substituted therefor to read in its entirety as follows:

"Section 18.766. Same—permit: revocation; suspension; hearing; notice.

Whenever any permit shall be issued by the Planning Department under the terms of this section the same may be revoked at any time thereafter, pursuant to Article 15 of Chapter 18 of this Code. Revocation shall be effected if the conduct of the business in question does or will in any manner endanger the public welfare or is conducted in an illegal, improper or disorderly manner, or if any requirement of this article or condition to the granting of a permit is not complied with.

Section 3. This ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety for the following reasons: Numerous branches of the peace have occurred in connection with drive-in, restaurants and public parking lots. The authority of law enforcement officers has been challenged when groups have congregated in such places. There has been a prevalence of thefts and general rowdiness and vandalism behavior in such places. Unless this ordinance is passed as an emergency measure numerous breaches of the peace are likely to occur.

Section 4. Any provisions of the Torrance City Code, or appendices thereto, inconsistent herewith, to the extent of such inconsistencies and no further, are hereby repealed.

Section 5. Any person violating any of the provisions of this ordinance shall be guilty of a misdemeanor and upon conviction thereof, shall be subject to a fine not exceeding Five Hundred Dollars (\$500) or six (6) months in the County Jail of Los Angeles County, or by both such fine and imprisonment in the discretion of the court.

Section 6. This ordinance shall take effect after the passage and adoption thereof, and the City Clerk shall certify to the passage and adoption of this ordinance and shall cause the same to be published once in the Torrance Herald, a semi-weekly newspaper of general circulation, published and circulated in the City of Torrance.

ORDINANCE NO. 1682
AN ORDINANCE OF THE CITY OF TORRANCE, CALIFORNIA, TO REPEAL SECTION 18.7 ENTITLED "RIDING OF MOTORCYCLES ON VACANT LOTS" TO CHAPTER 18 OF THE CODE OF THE CITY OF TORRANCE, 1954.

That Section 18.7 is hereby added to Chapter 18 of "The Code of the City of Torrance, 1954" to read in its entirety as follows:

"Section 18.7. Riding of Motorcycles on vacant lots.
Any person who rides a motorcycle or motor-driven cycle on any vacant lot in the city and disturbs a substantial number of persons in the neighborhood of such lot by noise, dust, smoke, or fumes caused by such motorcycle shall be guilty of a misdemeanor.

Section 2. Any provisions of the Torrance City Code or appendices thereto inconsistent herewith, to the extent of such inconsistencies and no further, are hereby repealed.

Section 3. Any person violating any of the provisions of this ordinance shall be guilty of a misdemeanor and upon conviction thereof, shall be subject to a fine not exceeding Five Hundred Dollars (\$500) or six (6) months in the County Jail of Los Angeles County, or by both such fine and imprisonment in the discretion of the court.

Section 4. This ordinance shall take effect after the passage and adoption thereof, and the City Clerk shall certify to the passage and adoption of this ordinance and shall cause the same to be published once in the Torrance Herald, a semi-weekly newspaper of general circulation, published and circulated in the City of Torrance.
