The City Council of the City of Torrance does hereby ordain as follows:

SECTION 1. That Section 16.566 of Article LIII, Chapter 16, of the Code of the City of Torrance, 1954, is hereby repealed in its entirety.

SECTION 2. That a revised Section 16.566, Article LIII, Chapter 16, of the Code of the City of Torrance, 1954, is hereby substituted therefor to read in its entirety as follows:

SECTION 3. Whenever any permit shall be issued by the License Department under the terms of this section the same may be revoked at any time thereafter, pursuant to Article IX of Chapter 16 of this Code.

SECTION 4. Any person violating any of the provisions of this ordinance shall be guilty of a misdemeanor and, upon conviction thereof, shall be subject to a fine not exceeding Five Hundred Dollars (\$500) or six (6) months in the county jail or both, fine and imprisonment in the discretion of the court.

SECTION 5. This ordinance shall take effect thirty days after the date of its adoption prior to the expiration of fifteen days from the passage thereof shall be published at least once in the Torrance Press-Herald, a semi-weekly newspaper of general circulation, published and circulated in the City of Torrance.

SECTION 6. Adopted and passed this 19th day of July, 1966.
