## Wong Wins Top Award For Model Car Design

Karlín Wong, a 16-year-old Narbonne High School student, has been named one of 18 award winners in the annual Fisher Body Craftsman's Guild model car competition. Wong previously had been named top state and regional winner in the competition. He will receive a \$1,000 college scholarship. Wong's victory in the 1966 competition marks the fifth consecutive time in which he won honors in the national contest.

Wong entered a metallic green sports coupe in the competition. His model features "gull-wing type front fenders and a bubble top design. He estimates he spent some 400 hours working on the model.

Craig R. Hover of La Mirada was among the 10 winners in the open division. The top awards, \$5,000 scholarships, were claimed by Ovid Ward, 21, of Roanoke, Va., and Dale A. Gnage, 15, of Rochester, N.Y. Wong is the son of Sing Wong of 1647 W. 228th St. His model was one of 10 selected for awards for excellence in design. He will be eligible to compete next year for the top scholarships, worth from \$2,000 to \$5,000.

**THE AWARDS** were presented at the Annual Guild Banquet, held at Fisher Body General Office in Warren, Mich., by Harold G. Warner, General Motors vice president in charge of body and assembly group operations.




