Satellite Engineer Honored

Capt. A. Howard Hayden of Torrance has been awarded the Air Force Scientific Achievement Award for his work aimed at increasing the in-orbit lifetimes of satellites.

A systems engineer, Capt. Hayden is primarily involved with Vela satellite detection systems. The Vela Program has provided the U.S. with a ring of eight satellites above the earth, capable of detecting any nuclear testing within the earth's atmosphere as well as in the far reaches of space.

Capt. Hayden won the achievement award for an experiment developed in connection with the last launch of Vela satellites. The experiment, carried "piggyback" aboard the Vela spacecraft, was orbited from Cape Kennedy in April, 1967, by a Titan III-C space booster.

The experiment is returning data which may help the Air Force slow solar cell degradation in space, and which would, therefore, prolong the orbital lifetimes of satellites depending on solar cells for power.

In addition to the Scientific Achievement Award, he has received two Air Force Unit Citations and two Air Force Commendation Medals.

Capt. Hayden is married to the former Barbara L. Chayler of Hawthorne.

Boat Registration Bill Introduced In Assembly

Assemblyman Vincent takes and errors occur. Thomas (D-San Pedro) has introduced a bill to transfer the function of registration of Motor Vehicles to the Department of Harbors and Watercraft to the Department of Motor Vehicles.

The measure, to be known as AB 1808, will return to the Department of Motor Vehicles the authority it had for registration of small craft vessels prior to 1962.

"I have not been pleased with the way the registration function has been conducted in recent years," Thomas said. "The Department of Harbors and Watercraft does not have branch offices throughout the state and all business must be handled by mail to Sacramento."

"The department has tried to overcome the problem by appointing private persons (usually boat salesmen) as registration agents," Thomas explained, "but these persons are generally unknown to the public and due to a large turnover of agents many mis-
