

'Operation Pep' Plans Discussed

'Operation Pep' a government-sponsored program to prepare educational planners to adapt industrial systems techniques to education, was described by Dr. Ross Harrington, superintendent of Redondo Beach City Schools, at the May luncheon of the South Bay-Harbor Industry Education Council.

Dr. Harrington, who is one of 100 California educators participating in the program, has attended six three-day sessions and a week-long meeting to explore the systems approach to problem-solving.

Included in the 100 participants of 'Operation Pep,' Dr. Harrington stated, are an equal number of school superintendents, assistant superintendents, and other educators, all of whom are under 50 years of age and have more than 10 years experience in the field.

BOTH URBAN and rural areas of the state are represented in the group. Participants are expected to spend 200 hours receiving training and an additional 100 hours reading special materials.

Why would educators want to learn the systems approach? According to Dr. Harrington, the reasons are three-fold:

- Information is coming at a more rapid pace than ever before.
A rising flood of innovations is appearing on the scene.
Education is becoming "big business"—\$155,000,000 worth of big business in California next year alone.

ACCORDING to Dr. Harrington, the systems approach can serve education as well as it has industry. Under this approach, there are three steps.

First, objectives must be defined in operational terms. Secondly, a systematic way of providing alternative routes of reaching goals must be provided.

And lastly, evaluation must take place. "Systems analysis has the pragmatic approach to problem-solving beat for one major reason," Harrington stated. "It goes one step further than trial and error."
