In 1965, Sheperd assumed the Chamber of Commerce manager's position in Lawndale, in conjunction with his public relations firm.

Sheperd has held many

state and national appointments in chamber and municipal committees and was on the board of directors for the Inter-City Highway Committee for five years, and was a member for a total of eight years. He also served on the board of directors of the South Bay YMCA, and is a member of the Redondo Beach Elks Lodge and Rotary Club.
