

Debating Group Elects President

Ed Hamilton, a member of the El Camino College Forensics team, will serve as president of Phi Rho Pi, a national junior college debating association, for the coming year.

Hamilton was elected at the Phi Rho Pi National Convention in Phoenix May 6 through 10.

Among Hamilton's duties will be to act as a liaison between the student debaters and their coaches and to represent the students at the National Executive Council meeting in

November in Wichita, Kan. He will also preside over next year's combined Phi Rho Pi convention and tournament at the University of Michigan in Ann Arbor.

"Having the national president of Phi Rho Pi at El Camino College is both an honor to El Camino and to the California forensics program," said Nathan Lilienthal, coach of EC's forensics team.

El Camino sent Ann Weber and the teams of Ed Hamilton, John Mangun and Terry Lush-

On June 1, she'll begin her second term as president of the Torrance League, a job that will entail countless hours of telephoning, organizing, speech-making, and study in the next 12 months. But it's time well spent in Mrs. Lanzer's opinion.

Why? The simple reason that League work makes her "a much more informed person" than she would be otherwise justifies the time and effort that the job requires.

Mrs. Lanzer also bubbles with enthusiasm when she reveals that "the group has some of the most interesting people I've ever met." She was more convinced than ever after serving as a delegate to the League convention in Anaheim this spring. "These women have such wonderful ideas that it's a pleasure to meet them!"

Mrs. Lanzer has been a League member since she and her husband Louis moved here from the east 12 years ago. Joining the Palos Verdes unit first, Mrs. Lanzer was on hand to help organize the Torrance branch in 1962. She was the group's first finance chairman and later went on to serve her first term as president in 1964-65. And she was first vice president this last year.

Mrs. Lanzer's community activities aren't strictly limited to the League of Women Voters, however. The blue-eyed mother of two serves several times a week as a noon aide at Riviera School, supervising the playground and lunch areas. "It's a lot of fun to see your children in an atmosphere you don't get to see them in very often!" Mrs. Lanzer mused. Las Madrecitas was another of her activities before League work took the driver's seat.

Mrs. Lanzer served as both auditor and treasurer for the auxiliary to the Crippled Children's Guild of Orthopedic Hospital. She has also done volunteer work at the hospital.

Born in Grand Rapids, Mich., Elizabeth (Tibby) Lanzer grew up in Milwaukee and later went on to become an honor graduate of Ripon College in Wisconsin. She studied math and English.

For seven years after graduation, Mrs. Lanzer was a secretary for a life insurance executive, a job which shuffled her from Milwaukee to Chicago and finally to Evanston, Ill. Married in 1951, Mrs. Lanzer and her husband came west in the fall of 1956 to ex-

plore the opportunities in the aerospace industry. Lanzer is currently a missile engineer at TRW.

The Lanzer children, both born on the West Coast, are Keith, 11, and Elizabeth, 8. Family life centers around camping jaunts — Keith went camping for the first time when he was only four months old!

Mrs. Lanzer names Yosemite as the family's favorite campsite. Lake Cachuma is another favorite. Fishing seems to be the main attraction for her husband and the kids. But Mrs. Lanzer prefers a quiet hike in the woods to the reel-and-rod scene.
