Sec. 1773 (Labor Code, State of California)
The body awarding any contract for public work shall include in the specifications a requirement requiring the payment of travel and subsistence payments to each workman needed to execute the work...

FORFEITURE FOR PAYING LESS THAN PREVAILING RATE; RIGHTS OF WORKMEN; ESTABLISHMENT OF CONTRACT; RECOVERY BY DIVISION OF LABOR LAW ENFORCEMENT WHEN BROUGHT; NOTICES; PROCEDURES

The contractor shall, as a penalty to the State or political subdivision on whose behalf the contract is made or awarded, forfeit twenty-five dollars (\$25) for each calendar day, or portion thereof, for each workman paid less than the stipulated prevailing rate...

APPRENTICES—May be employed in conformity with Section 1777.5 of the California Labor Code.

RIGGERS—Same wage scale as craft to which rigging is incidental.

WELDERS—All welders not herein separately classified shall be paid the daily rate of the highest classification in which he has supervision in the six basic trades.
