**ELECTION ORDER IS RESCINDED BY BOARD**

ors purported to have been given by the "undersigned" the petitioners, and I do not think such a reference to undersigned petitioners will constitute them the signers of the notice, even though the petition is copied into the notice as a part thereof. I therefore advised the Board of Supervisors when the matter was referred to me that I did not think they had jurisdiction to act on the present Torrance petition, the notice of which was given in the same manner as the Montebello notice.

It is reported that certain oil interests in Montebello are threatening to bring suit to declare void the proceedings by which Montebello was incorporated on the ground that sufficient notice was not given.

While the decision may not result favorably to the oil companies, yet if they are successful it will mean that the legality of the incorporation of many Southern California cities will be jeopardized and Torrance in that case will have been fortunate to have followed the new form of procedure suggested by the County Council.

**LOMITA PROTEST NOT DECIDED**  
Following is a copy of the minutes of the Board of Supervisors respecting the Torrance Incorporation matter at the hearing held January 28, 1921:

"In re-proposed incorporation of Torrance, order rescinding resolution calling election.

"This being the time fixed for further hearing on protests against the incorporation of Torrance as a city of the sixth class, and against inclusion of certain territory within the limits of the proposed city, the matter is called up, and the following report is presented:

"January 28, 1921.

"Hon. Board of Supervisors, County of Los Angeles, Cal.

"Gentlemen: At your request we have examined the proceedings had up to date in the incorporation of the City of Torrance. Because of a defect in the notice published prior to the presentation of the petition to the Board of Supervisors, we beg to advise that in our opinion the Board of Supervisors did not have jurisdiction to hear said petition, nor to fix the boundaries of the proposed city, nor jurisdiction to call an election in the district to be incorporated, upon the question of incorporation.

"Whereupon, on motion of Supervisor Cogswell, duly seconded and carried, it is ordered that the resolution adopted by this Board on Dec. 20, 1920, calling an election to be held on February 1, 1921, for the incorporation of said city be and the same is hereby rescinded."

The stenographic report of the meeting of January 28, before the Board of Supervisors shows that the question of the inclusion of the territory lying south of the Long Beach Redondo Road was informally discussed at length during which discussion some of the supervisors appeared to favor the inclusion of such territory and some apparently favored its exclusion. No statement was made by any supervisor as to how he would vote on the question of excluding such territory, however, and it was informally decided by the members of the board at the suggestion of Mr. Carter, as attorney for the people living in the district and without objections from the proponents of incorporation, that the board would leave as an open question the matter of exclusion or inclusion of territory in dispute, and no action was taken with respect thereto or with respect to the protest of the people living in the district lying South of Redondo Road as will appear from the following abstract of the stenographic report:

"Mr. Cogswell—I make the motion that we now rescind the order calling the election for the City of Torrance."

"Mr. Dodge—It is moved by Supervisor Cogswell that the original order made December 20, of this board calling for an election for the incorporation of Torrance be now rescinded. Is there a second?"

"Mr. Woodley—Second."

"Mr. Bean—That is under the decision of the County Counsel?"

"Mr. Woodley—Yes. Under the ruling of the County Counsel."

"Mr. Dodge—All in favor of the motion say Aye. (VOTE.)

"Contrary, NO. Carried."

After discussion as to whether the territory south of Redondo Road be included in the next petition, Mr. Carter addressed the chairman of the Board as follows: "Mr. Chairman, may I say a word? We don't care to go into a contest and have this fixed now, they will have to present the petition. **STREET GRADING CONTRACT AWARDED**

**"HAMMERTON" STREETS TO RECEIVE MUCH WORK**

The contract for the grading of the City of Hammerton, East of Torrance and the profiling of the entire eighty-acre tract was awarded Saturday to Coy Farquhar of Harbor City. Already Mr. Farquhar is moving his equipment of heavy fresnos, graders, scrapers and other implements, that he will use in preparing the contour of the new city and would have started the work Monday morning had not the heavy rains made it impossible to begin work.

The contract was awarded for \$40,000 and the first unit of eighty acres will be put into shape, streets cut through, graded and surfaced ready for paving. The curb lines will be rounded out and the tract will be uniformly leveled and filled in where needed.

This extensive work will consume the greater part of the next three months and it is doubtful if the job can be completed within ninety days time. However, many of those interested in the Hammerton tract are jubilant that work has actually started on the new townsite, and H. H. C. Hammerton, promises that "there will be something doing" right along from now on.

The contractor will build several buildings for storing and guarding his large equipment and will provide housing accommodations for his foreman who will be on the job night and day. The work will be started off with at least twelve men and twenty-four mules, and Mr. Farquhar promises to make the dirt fly.
