ORDINANCE NO. 235
ORDINANCE PROVIDING FOR LICENSING AND REGULATING THE CARRYING ON OF CERTAIN PROFESSIONS, TRADES, CALLINGS AND OCCUPATIONS CARRIED ON WITHIN THE LIMITS OF THE CITY OF TORRANCE...

SECTION 1. It shall be unlawful for any person, whether as principal or agent, clerk or employee, either for himself or any other person...

SECTION 2. The amount of any license imposed by this Ordinance shall be deemed a debt to the City of Torrance...

SECTION 3. It shall be the duty of the City Clerk to prepare and issue a license under this Ordinance...

SECTION 4. All licenses shall be paid in advance in the legal currency of the United States...

SECTION 5. No greater or less amount of money shall be charged or received for any license than is provided in this Ordinance...

SECTION 6. Every person, firm or corporation having such license and not having a fixed place of business...

SECTION 7. The City Marshal and all Police Officers of said City shall have and exercise the power...

SECTION 8. The conviction and punishment of any person for transacting any business, trade, calling, profession or occupation without license...

SECTION 9. The daily license in this Ordinance provided, shall be payable to the City each day in advance...

SECTION 10. No license or permit shall be required under the terms of this ordinance for the conducting of lectures, concerts, shows, or entertainments by non-profit organizations...

SECTION 11. Upon written application to the City Clerk, the City Council may, upon a four-fifths vote of its members, allow and order a refund of that unused or unearned portion of any license fee paid hereunder...

SECTION 12. The rates of licenses for the professions, trades, callings and occupations hereinafter named, shall be, and the same are hereby fixed and established for and within the City of Torrance...

SECTION 13. The rates of licenses for the professions, trades, callings and occupations, as follows to-wit:

1. For every person, firm or corporation engaged in the business of conducting, managing or carrying on any hotel, boarding house, apartment house or lodging house, \$12.00 per annum.

2. For every person or firm carrying on or conducting a law business, payable in advance, \$12.00 per annum.

3. For every person, firm or corporation carrying on the business of automobile garage, \$12.00 per annum.

4. For every person, firm or corporation conducting, managing or carrying on a bakery and selling at retail or at wholesale, the baked goods produced in such bakery, \$12.00 per annum.

5. For every person, firm or corporation operating, managing or carrying on a circus, \$50.00 per day.

6. For every person, firm or corporation operating any cart, wagon, automobile, auto truck or vehicle for the local delivery of freight or goods...
