State Prepares For Food Crisis Of Next Winter

Resources of California Organized to Feed Hungry Unemployed

SACRAMENTO.—(U.P.)—California will feed her hungry this winter on a scale never before attempted in the history of the state.

Governor James Rolph, Jr., who knows the seriousness of the situation facing every county through personal visits, has placed the entire machinery of the state government in motion to aid in meeting the crisis.

He declared an emergency to exist, set up the office of food administrator and placed Dudley Moulton in charge, with power to commandeer food supplies, if necessary, to relieve want and misery.

He authorized the establishment of 40 labor camps to house 7,000 single unemployed, itinerant and give them food in exchange for labor in building fire trails.

He ordered the resumption of 3-day-a-week highway camps, with an appropriation of \$1,000,000, to provide work for heads of families and local citizens in California.

All kinds of food, and in almost every imaginable quantity, is being furnished to the counties. San Joaquin county potatoes are being traded for Los Angeles county oranges.

Flour, stock feed and cereal is supplied by the Red Cross. Already a total of 120,000 barrels of flour, of which 49,493 barrels went to Los Angeles county, has been distributed to the 58 counties of California from the first 40,000,000 bushels of government wheat to be milled.

Food Administrator Moulton has recognized two large groups of unemployed, in Alameda and Los Angeles counties, who have volunteered men to go into every section of the state to harvest, store and distribute surplus fruits and vegetables. All these men receive for their work is food for their own families.

"The Alameda organization, with a membership of 8,000, has offered to donate 16,000 hours of free work a month," said Moulton. "The organization has also declared it will harvest crops for farmers who cannot supply labor, the only consideration being that the surplus crops shall go to the unemployed."

Cotton Cloth For Clothing Issued to Local Relief

Several Organizations Help In Sewing For Torrance Needy

Unemployed and needy persons in Torrance will be supplied with clothing this winter through the activities of local organizations which are working with Mrs. Caroline Collins, local representative of the Los Angeles Red Cross headquarters, which is distributing the government supply of cotton cloth.

Already several church guilds and other volunteers are turning out dresses, pajamas, and other garments, made up from the bolts of prints, ginghams, shirting and outing flannel which has been delivered to the headquarters here.

The Episcopal Guild, Catholic Altar Society, Methodist Ladies Aid, Evangelical Guild, are among those already contacted and busy on the work. More volunteers are wanted. All other women's organizations are invited to take up the work of cutting and sewing garments, and those who are willing to aid in the work are asked to get in touch with Mrs. Collins.

Cotton cloth is being supplied free by the government, in the same way that free flour is distributed, through the agency of the Red Cross chapters. Many communities throughout the country have taken advantage of the offer.

The cloth supplied by the government is of good quality, in a large variety of colors and designs. The completed garments have all the freshness and charm that comes from the beauty of the patterns and the skill with which they are made.

Already a number of bolts of cloth have been made up, but Mrs. Collins has on hand some 14 bolts to be used, with a large supply to draw from at the storage warehouse in Los Angeles.

Red Cross chapters in the Pacific states have requisitioned enough cotton cloth to meet the needs of 218,922 families in distress, the materials totalling 3,441,003 yards according to a compilation as of September 22, announced by A. L. Schaefer, manager of the Pacific Branch Office, San Francisco.

Cotton materials are being received rapidly in sewing rooms of coast chapters and thousands of volunteer workers have begun the task of converting the supplies into clothing for men, women and children.

James L. Fieser, vice chairman in charge of domestic operations, personally in charge of the central cotton distribution office at Washington, D. C., reports more than 100,000 women have volunteered throughout the United States to operate the Red Cross sewing rooms.

Chapter requisitions nationally thus far exceed 20,647,363 yards of cloth, providing materials for more than 1,679,512 families. Mr. Fieser says: "As in the flour distribution, chapters have been warned that the cloth or clothing must not be exchanged for work. It must be given absolutely free and solely upon the basis of need. No other consideration must enter into its distribution."

Redondo Man Jailed For \$10,000 Theft

Ray Foster Long, bookkeeper for the People's Finance Company of Redondo Beach, was sentenced to serve 90 days in the county jail on each of five counts brought against him, following his confession of the theft of \$10,000 from his employers. The thefts were carried on over a period of two years, Long made a voluntary confession and was sentenced the following day. He was one of six unsuccessful candidates for city councilman in Redondo Beach during the spring campaign.

A skit by the "A" English class was given, showing the advantage of the student body ticket, which last year cost \$2.50 and which this year has been reduced to only \$1.00.

The commissioner of athletics, Herman Hammer, also gave a short talk on the ticket.

This year's council was introduced, and a speech was made by Bill Parks, the student body president, regarding the conduct in the auditorium. In the past we have had officers assigned to different sections. His talk was as to whether we should retain them.

Arthur G. Waidelich, the new principal, read a humorous poem which he used as an example for the student body tickets. He said he wished he could set every student aflame with enthusiasm to buy one of them. He urged the students to buy them. I hope we can prove to Mr. Waidelich that we have all an more enthusiasm and school spirit, than he remarked upon.

John Ferguson Leases El Prado Service Station
Active management of the El Prado Service Station and Auto Laundry, corner of El Prado and Carson street, was taken over this week by John Ferguson, well-known Torrance resident. The station was originally owned by Col. J. E. Forbes but more recently has been operated by Dewey Lantz.

Mr. Ferguson is well known to local motorists. He formerly operated the Union Oil Company station at Carson and Arlington, and for the past year has conducted a service station at 1080 Narbonne avenue, Lomita. Previous to entering the service station business, Mr. Ferguson was associated with the Columbia Steel Company, among whose employes he still has a large number of friends. Mr. and Mrs. Ferguson have been residents of Torrance for the past ten years, owning their home at 2355 Sonoma avenue.

General Petroleum products will be sold exclusively at the El Prado Service Station and Auto Laundry, Mr. Ferguson stated.

Bids For Linoleum Opened On Monday
The Lindley Carpet Associates submitted the low bid for furnishing linoleum and rubber base for the new Torrance health center. It was learned following analysis of the bids opened Monday afternoon by the board of supervisors. Their figure was \$1500 for a one-inch floor, or \$1950 for two-inch floor.

The Broadway Department submitted the only other bid, at \$1750 for one-inch and \$2075 for two-inch floor. Contract is expected to be awarded late this week or next Monday by the supervisors. Bids are to be opened October 10 for furnishing movable partitions for the handsome new building.

Gardena Receives Money For Roadwork

Allocation of \$2625 was voted by the city of Gardena this week by the county board of supervisors, in payment for street improvements completed by labor supplied by the county welfare department. The work was done upon Riverside-Redondo boulevard, between Vermont and Arlington avenues, entirely within Gardena.

Redondo Beach received \$2725 for various street jobs, Manhattan Beach \$1749 for West Boulevard drive, and Hermosa Beach got \$520 for 21st street.

Torrance received no allocation from this source.
