

Special Court Order Needed to Permit Operation

A special act of the superior court was necessitated in order that William L. Johnson, 14-year-old Gardena high school boy, might undergo an operation late last week at the Orthopaedic hospital in Los Angeles.

Before the hospital would perform the operation, which resulted from injuries received in a football game, the consent of a guardian was necessary, it was stated. As the boy's father is dead and his mother is confined to a hospital, his grandmother, Mrs. Nora L. Bacon, filed the necessary petition in probate court. Less than an hour afterward, the court had signed the order appointing her as William's guardian and the hospital proceeded to perform the operation.

The injuries consisted of a broken shoulder and collar bone, and the court was told the operation was necessary immediately in order to save the boy's life.

The barbers of Torrance who are members of the Journeymen Barbers International Union of America, Local Number 881, at a meeting held Friday, Nov. 3rd, decided to ask for space in your paper to appeal to the fairness of the people of Torrance in regard to conditions that they have to meet under the Barbers Code.

The Code is now in effect and along with other organized barbers of Southern California, the Torrance barbers have set forth a price for their work in compliance with the code, and feel sure that the prices set are fair both to the customer and the barber and as it would seem that all lines of employment will operate under a code in the future, it is not a question of whether these codes can be enforced by law, but in view of the fact that our President is taking this means in an effort to relieve suffering due to the depression and to try to accomplish something for the com-

mon welfare, we feel that it should be the duty of all of us to cooperate as much as possible.

Organized barbers uphold the laws of their community and their country. Who responded more sincerely to the N. R. A. than the union craftsmen of the country? Only through co-operation can there be success in any venture. Then why should the barber who conducts his business as an honest upright citizen and who tries to live and rear his family according to the American standard of living be subjected to the lowest form of thievery—Price Cutting. Price cutting is an illegal form of conducting a legitimate enterprise. It is unfair competition—competition should be fair tactics of service and workmanship.
