With Ella Levy presiding, the G. A. A. held its first meeting at which it was decided that the Torrance G. A. A. would be hostesses to Narbonne, Gardena and Hanning high schools at a play day to be given in the early part of December. Plans for the play day were discussed and committees were chosen to start making preparations. Gifts who are interested in G. A. A. must earn 100 points during the semester in order to stay on the roll of the club. This year there will be after-school basketball practices and the winning team will receive 100 G. A. A. points. Those who do not make the winning team will be given 25 points for coming out to the practices which will be held on Wednesday afternoon.

Recently Major Schoof of the Canadian Mounted Police gave a most exciting talk about his experiences as a globe trotter. Mr. Schoof showed the students many interesting relics including the skins of zebras, lions, bears, leopards, snakes and crocodiles. The most interesting were the skin of a lion who had eaten one of Schoof's friends, killed a horse, and consumed six natives; and the skin of a crocodile 72 feet long that had eaten many of the men on the party. He told of his journeys through jungles with grax six and seven feet high and infested with snakes, lions, etc. Major Schoof was from Germany originally and came to America for his health when he was eight years old. His talk was very thrilling and was enjoyed by all students who attended the aud call.

Many of the students are interested in knowing that the school library had received a shipment of new books. Some of the books are "Young Mexico" by Richard Carvel, "Men and Machines" by Babbit, "Authors Today and Yesterday" and "Radio Amateurs' Handbook."

It was announced at the high school that there would not be a loose-leaf annual as formerly planned, but that the regular annual year book would be published. However, the Monthly Torch will also be published, and it will replace the T. N. T., the old school paper.

Good news was received by Mr. Waldelich that Mr. London Corbett had accepted our invitations to the Torrance-Narbonne game. An inter-class contest was staged at the high school, the result of which was 70 letters sent to Mr. Corbett inviting him to the game.
