Mistaken Identity Causes Arrest Of Lomita Men On Assault Charge

Clyde W. Rownd, and his son, Ellis Rownd, of Lomita, plead guilty July 20 to simple assault in the Lomita justice court and were fined \$5 each or two days in the county jail, and were released on payment of the fines. An additional sentence of 30 days in the county jail was imposed which was suspended for two years on condition that the men keep the peace.

Rownds and his son were arrested on July 3 on a charge of assault with a deadly weapon, preferred by Felix Graf, also of Lomita, who with three companions were starting on a fishing trip to Redondo Beach. As they were passing the Rownds home on Narbonne avenue, testimony showed that the two accused men drove out of their driveway and halted the other car. The two are said to have leveled revolvers at the four men, but offered no further personal damage beyond a verbal trade. After the hauling out, the Rownds went back into their premises and the other car was allowed to proceed. The fishing trip was ruined, however, for the four men and they also returned home.

It appeared later that the Rownds men mistook the car in which Graf and his companions were riding for another machine which had been molesting them several times. The Rownds are employed at the docks and are said to have believed that Graf and his friends were strike pickets. Under the circumstances the deputy district attorney withdrew the felony charge and allowed the accused men to plead guilty to simple assault, a misdemeanor.

Graf is a well-known resident of Lomita, a trainer of dogs for movie picture work. None of the four men had any connection with the strike at the docks or are employed there.

Gasoline Sales Show Increase Over Last Year

General Petroleum Reports Gain of 22.42 Percent During Past Five Months
