

General Petroleum Holds First Place In Accident Prevention

First place in accident prevention among the marketing departments of major oil companies of the nation. Such is the distinction won by the marketing department of General Petroleum Corporation for the first five months of 1936, according to news just reaching F. C. Davies, Southern California sales manager for this large oil producing, refining and marketing company of the West.

"It will be remembered," he says, "that, about a month ago we announced General Petroleum marketing department in second place in the safety campaign for the first four months of this year. At that time, the prediction was made that our department would go to first place nationally. When all records were tabulated by the National Safety Council, Inc., for the five months ending May 31, we actually were found at the top of the list.

Only One Mishap
"General's marketing department, embracing approximately 1,500 persons engaged in operating cars, trucks, bulk plants and service stations, had but one disabling accident in this five months' period in all the territory served by the company, including Washington, Oregon, California, Arizona and Nevada. "This one accident—a slight one—happened during the period in which this department registered 1,059,587 man-hours of labor. This is a frequency of .944—or 94 hundredths of one accident per million hours. The average number of accidents in the marketing division of major oil companies during this five months' was 9.92 per million hours."

The first in his profession to employ women on the serving staffs of liners, Lawrence made it a custom to select young women from the colleges of the country for the jobs, and thus afforded them the opportunity to spend their summer months traveling. At times co-eds from a dozen or more different schools were included upon the same staff.
