

Big Fish Out of Sky Creates Plane Mystery

KLAMATH FALLS, Ore. (U.P.)—The first "mysterious aerial bombing" to occur on the Pacific coast occurred here when what is believed to have been at least a 10-pound fish hurtled down through a tree and struck the rear trunk of Francis McCarthy's automobile, inflicting a large dent.

Although the fish is believed to have fallen from or been thrown from an airplane that was heard flying overhead about the time the "bombing" occurred, a police investigation revealed no clues.

LAW FIXING TAX RATES ADOPTED

Adoption of Ordinance No. 305 as an emergency measure to establish the city tax rate for the coming year formed the principal business transacted at an adjourned meeting of the city council Tuesday night. The rate as fixed is the same as had been forecast last week, for District No. 1, \$1.10, and for District No. 2, \$1.07.

Budget figures are based on an assessed valuation of \$20,500,000, an increase of \$1,545,805 over last year's total.

One other ordinance, establishing a set-back line on Arlington avenue between Redondo Beach boulevard and 190th street was adopted. Before proceeding to the main business of the session the council cleared the decks of written communications involving requests for action on various matters.

MATS MISSING... First on the list was a complaint from the proprietor of the Dolly Drug annex, who informed the council that the city pick-up man had carried away (by mistake) three rubber mats, 40 inches wide by seven feet long. The mats had been placed outside to be cleaned and when wanted later were missing. "Shouldn't this be referred to the bull fiddle department?" Councilman Hitchcock asked when the motion was adopted to put the matter in the hands of his street department.

DIPLOMACY WINS... An oral plea by Rev. M. E. Nicholls, pastor of the Foursquare church, for permission to use an amplifier system on his car to advertise twice a week services at his church, was granted. Earlier in the evening, during the absence of the pastor the written request had been discussed but a motion to grant the permission was lost for want of a second. Rev. Nicholls diplomatically pointed out that the city has no ordinance covering the matter, and assured the council that they did not propose to "make a nuisance of themselves." The permit was granted for 30 days, at the end of which time if there are no complaints from citizens an extension of time may be allowed.

WANT LIGHT... Window peckers and burglars in the vicinity of Columbia Court moved 25 residents of that street to send a petition to the council asking for a light to be placed at the intersection of Columbia Court and Dominguez. Investigation will be made of the needs of the neighborhood, and also of the need for lights at the ends of Acacia and Beech avenues.

LOCATE SIGN... A request by the Chamber of Commerce for permission to locate one of the new highway signs advertising Torrance at Western avenue south of Torrance boulevard was granted.

ASK REZONING... A request from Tom Waters, representing the owner of lots 1 and 2 in Block 19 for rezoning under business classification was referred to the city engineer. The lots, located across from the Safeway store on Carson street, are now zoned under the apartment house classification. Waters, in his letter to the council, pointed out that other lots in the same block have already been zoned for business and are occupied by stores, and gave as the owner's rezoning request the increased possibility of disposing of the lots at a fair figure, or of using them for business purposes.

REFUSE EXTENSION... An oral plea by the proprietor of Grey's tailoring shop, recently opened at 1621 Cabrillo avenue, for an extension of time to pay his business license, was refused. Under the city ordinance the council has no power to make such a concession.

objectives of breeding class hatred. He recalled an incident in which a Gardena mother upbraided Geyer for "taking high school boys off the school grounds and holding private classes in what he termed 'were the true interpretations of social problems of today.'"

Opening his address, Dr. Lechner stated that Communist and Fascist forces were the gravest dangers confronting America at the present time. Thousands are working thru subsidiary organizations controlled by the Communist party to the detriment of American ideals and institutions, garnering votes thru mass hatred and building up political power in one form or another, he pointed out.

Candidates Present... "These people are using their power of class hatreds to stir up the seeds of Communism. California is being used as a 'proving ground' for such influences," he declared. Dr. Lechner concluded his address with his definition of American society:

"It is a sacred compact between the dead, the living and the unborn whereby the living take from our ancestors a heritage of loyalty, courage and determination to preserve our American ideals and institutions and pass it on to generations yet to come—unspooled and untarnished. This is our duty as citizens. We have no room in this country for destruction, dishonesty and class hatreds and we must strive to bring men to public office who uphold our heritage."

Commander Grant Barkdull, president for the last time over the series of dinner-meetings open to all men of the community which he instituted last year, introduced the guests present, including Dr. Charles W. McQuarrie, Gardena Legionnaire and Democratic candidate for Congress, and James J. O'Toole, well-known local resident who is campaigning for the Democratic nomination to the state assembly.
