New Trial Denied City of L. A. in Auto Plunge Suit

Judge Percy Hight in Long Beach denied the city of Los Angeles' motion Tuesday for a new trial of a damage suit resulting from the death of one man and injury to two others when their car went over Pt. Fermin cliff March 15, 1939.

Attorney Joe Raycraft for the plaintiffs, who last January were awarded a total of \$26,573 damages by Judge Hight, said he understands the city will carry the case to the district court of appeals.

The Long Beach jurist heard the motion for a new trial last Thursday and this week denied the Los Angeles city attorney's motion which was entered on the grounds of new evidence. He ordered judgments to stand, calling for payment of \$20,500 to Clarence Comer of San Pedro, still hospitalized from injuries; \$5,500 to Mrs. Fanny Rippe of 1005 Maple street, Torrance, widow of Bud Rippe, killed in the crash; and \$573 to Chris Jones of 2112 Carson street, Torrance, who was thrown from the car just before it went over the cliff.

The three longshoremen were going out Pacific avenue to pick up a fourth man when their car missed the turn in a heavy fog and hurtled down the Pt. Fermin bluff. Attorneys Raycraft and Rufus G. Porter charged the city of Los Angeles was negligent in failing to repair and maintain an already damaged fence in front of the cliff.

M.W.D. to Erect Chlorination Plant at P.V. Reservoir

May 2 has been set for trial of the condemnation action by which the Metropolitan Water district is acquiring a right of way for its feeder line between East 98th street in Los Angeles and Palos Verdes reservoir, it was announced today.

Construction of the reservoir now has been completed and landscaping work is under way along the steel fence which completely surrounds the reservoir.

Construction of a caretaker's house at the reservoir will be started as soon as a contract has been awarded on the basis of plans now nearing completion, it also was stated.

A chlorination plant also is to be installed this summer at the Palos Verdes reservoir, which will supply water to the cities of Torrance, Long Beach, Compton, Wilmington and the rest of the harbor district. The water, which will have undergone a softening and filtering process at a large plant now under construction near LaVerne,
