Home Repair Priorities Are Granted

Priorities were granted today to Southern California home owners who need small quantities of lumber for repairs, Stanley Mark, local WPB chief, announced.

The order can't replenish the practically bare lumber yards of this area, Mark conceded; but it will save the home owner the trouble of applying to FHA for permission to make necessary repairs. The order covers only lumber needed or emergency repairs or damage by fire or water or similar causes. The damage must render the dwelling unfit for habitation unless it is repaired at once.

It defines a "home owner" as a person who owns and occupies a one-family housing unit. It gives automatic priority to the home owner who indorses his application with a written certificate of need. It permits the lumberman to release the lumber, but limits his yearly sales to the volume of his 1944 sales, or ten thousand board feet, which ever is greater.

It does not apply to farmers, who must obtain their priorities through their county AAA.

Fines In City Court Total \$2316 For June

From June 1, to and including June 30, 1945, the City Court of the City of Torrance received \$2316 net from fines and fees. Of this sum \$917 are General Fund monies, while \$1395 came from vehicle violations and thus are Road Fund monies.

General Fund monies were collected from the following cases: Drunkenness, \$530; Parking, \$57; Boulevard stop, \$190 and miscellaneous criminal violations, \$140. One civil case was filed, a total of \$4.

Road Fund monies were derived from the following: Drunk driving, \$688; speeding, \$648 and miscellaneous traffic violations, \$159.
