Barge Pier For Portuguese Bend Is Authorized

Approved by the Civilian Production Administration the start of construction of a barge-loading pier in Portuguese Bend, Rancho Palos Verdes, was announced today by Kelvin C. Vandierip, president of the Palos Verdes Corporation.

The pier will be used to ship breakwater rock from the vast deposits of this material in the Portuguese Bend area.

Construction of the marine facility, the first of its kind in the 400-year-old history of the Palos Verdes Peninsula, is expected to be completed by early July.

The structure will be 432 feet long and 20 feet wide. It will project southward from a point just east of Inspiration Point, the western extremity of Portuguese Bend. The pier will be privately owned and operated.
