Make Slip Covers, with a 'Professional' Look at Home

Perhaps if the chairs in your house could speak they'd ask for a 'facelifting.' But, poor you, you'd answer: 'Oh, my aching budget, I can't afford new slip covers. They're too expensive.'

Making slip covers isn't as hard as it sounds. True, there are tricks to simplify the job, but if someone showed you those tricks, don't you think you could do it?

An eight-page story, outlining each step in the making of slip covers, written by Mary E. Monze, decoration editor of The American Home Magazine, appears in the April issue, and shows, through text and almost 60 photographs, how to measure for correct yardage, how to pin, fit, baste, stitch and finish a chair cover.

Using one squat, comfortable but seedy-looking chair as her guinea pig, Mrs. Monze transformed it into a self-respecting piece of furniture. The tricks she used can be your very own, and here they are.

First, carefully measure your chair for yardage. Get a note book and jot them down. (Measure each of the chair's surfaces, back, seat, arms, cushion, distance around the bottom of the chair, etc.) Then add up lengthwise (not width) measurements and divide by 36 inches. This will be a basic yardage but add an extra yard if the fabric has a design that must be centered. Allow 2 inches for all seams, plus 3 inches for 'tuck-in' on the inside of the chair at back, sides and seat.

Now consider your material. It should be pre-shrunk, fast color and sturdy in weave. For the chair illustrated in her article, Mrs. Monze used a new, tested, stonewash fabric which retails for about \$2.50 per yard and is available in a choice of five color combinations.

Using a fairly large table for cutting, the next step is to block out, with chalk and ruler, the shape of pieces to be cut. For example, if the chair back measures 39 inches high and 26 inches wide, plus the 2 inch seam allowance, you should block out a piece of fabric which measures 43 inches by 30 inches.

Next step is to pin-fit the pieces on the chair—the back of the chair is the place to start. Center the pattern, place pins evenly, starting from the center and work out in either direction. This insures a neat fitting cover.

The pieces then are ready to sew together. If you are using a corded edging—white cotton covered with bias strips of material—stitch the cording to one piece at a time, unless it is a joining on a straight seam and then the two pieces can be joined in one operation.

Mrs. Monze suggests that by pressing the cover as the sections are stitched you will have a more tailored and professional result.

The great advantage in home sewing today is that the modern sewing machine has different attachments for doing a good job. Mrs. Monze used the cording foot and the bias cutting guide on her Singer machine to make the neat, tight joining cord. She could regulate the tension for different lengths of stitches.

Photographs in the article show steps close-up so that the beginner doesn't miss the detail work. The text explains just what to do when! Piece by piece sections are completed—when the back is done do the chair arms, then the seat and lastly the skirt.

Maybe the project sounds terrifying—you've never made a slip cover and you wonder whether you'll ever finish it once you've started. Go ahead—try it, tack up the pictures and the text to guide you and show the kids, the cat and the pup out to play. You're going to!
