**National Opens
New Store In
Bakersfield**

**COURT RULES TIDWELL,
CLERKS UNION OFFICERS,
MUST ANSWER QUESTIONS**

On Friday, April 16, Judge Clarence M. Hanson ruled that Haskell Tidwell and other officers of the Harbor Area Retail Clerks Union, Local 905, must answer questions in depositions that are being taken from these men in connection with the retail store cases in which these men appear as defendants.

Previously these men had appeared for depositions but refused to answer questions on the technical grounds that there was no cause for action. Judge Hanson's recent ruling held that there was sufficient cause for action.

Tidwell and other officers of Clerks' Local 905 are defendants in suits brought by three Harbor area stores charging that the union leaders and their union picketed these three stores in efforts to try to force the employers to commit illegal acts by signing illegal closed shop contracts.

The employers involved—Williamington Hardware Company, Caldwell's Department Store and Spears Store for Men—asked damages against Tidwell et. al. of \$75,000 plus a permanent injunction to keep the union from further acts to force the employers to sign an unlawful closed shop contract. Judge Hanson has already granted a temporary restraining order to that effect.

In ruling that Tidwell and the other union officers must answer questions taken at deposition hearings, Judge Hanson stated that the court would have jurisdiction of the subject matter of the causes of action alleged in the original complaints. He also ruled that the defendants have made no showing that any injustice would be done by any person concerned by the mere taking of the depositions.
