Posthumously Awarded Medals Go to Widow, Daughter of Hero

An Oakleaf Cluster to the Distinguished Flying Cross and the sixth Oakleaf Cluster to the Air Medal were presented posthumously last Friday to the Torrance wife and five-year-old daughter of a B-29 pilot killed in Korea last November.

Accepting the medals during a solemn ceremony held at the Long Beach Air Force Receiving Training Center was the airman's pretty wife, an ex-mo- del, Mrs. Mary M. Laden, and daughter Alexa, of 2180 Andro- ceo avenue.

Captain Laden, a veteran of 13 years in the service, was killed on November 5, 1950 en- route back from a mission over enemy territory in Korea. Capt. Laden, a pilot of a B-29 type photo reconnaissance plane, had dropped to 13,000 feet to get much-needed photographs of en-emy activity. He was jumped by Red jet fighters and had one engine shot away. In spite of this, the crew is credited with downing one Red plane. He con- tinued his photo run in spite of a heavy ant aircraft fire from the Reds. En- route back to his base a second engine went out. Realizing that the plane would never make it back to the base, he alerted the crew for a crash landing, delaying the action while his crew prepared for the impending crash. His actions and un- flinching devotion to duty are credited with saving the lives of seven crew members.

Mrs. Laden, who was living in Japan with her husband at the time of the crash, accom- panied his body to San Jose, California, his hometown, where he was buried. He attend- ed San Jose State College be- fore entering the service.

The war hero's widow moved to Torrance after the funeral, to be near her mother, Mrs. S. O. Gooding, 125 W. 219th place. Captain Laden, a B-17 pilot during World War II with the 306th Bomb Group of the Eighth Air Force, had 35 missions to his credit in the European The- ater. He has been awarded the Purple Heart with Cluster and the Victory Medal.

Making the presentation of the Distinguished Flying Cross and the Air Medal last Friday was Colonel Lee Q. Wasser, com- manding officer of the 2347th AFRTC, Long Beach.

City to Get Treasury Bond Flag

Torrance has qualified to be- come a U. S. Treasury Depart- ment Flag City—the first in California.

For the city it will mean con- siderable publicity on a National scale, according to treasury de- partment officials who plan to make an "example" of Torrance.

The campaign to qualify Tor- rance as a Minute Man Flag City was sparked by the Tor- rance Junior Chamber of Com- merce under the chairmanship of George Post. The Jaycees met and topped a goal of 80 per cent signers to a pledge by em- ployers that they would make defense bonds available to em- ployees through payroll deduc- tions. The Juniors are at- tempting to give other cities a real mark to shoot for by ob- taining a 100 per cent sign-up of employers in the area.

Planned for later this month is a treasury-sponsored parade including marching units from the Army, Navy, and Marine Corps, according to Stanley Switzer, deputy director of the treasury savings bond division. Motion picture stars and govern- ment bigwigs are to attend the celebration, he said. Newsreels and television coverage is ex- pected, Switzer said.

Already, according to the treasury department official, National Supply Company has 34 per cent of its employees taking advantage of the payroll deduc- tion plan. Columbia Steel has topped that mark and now has 79 per cent of its workers buy- ing savings bonds through a payroll deduction plan.

Exact date of the parade and celebration is to be announced sometime next week.

YAMOTO, Japan.—Torrance's Company A, 574th Engineers Combat Battalion, has headed for the field again to take over road and bridge repair projects near Sendai.

This is the Torrance unit's second such assignment, it hav- ing returned recently from a week of rebuilding narrow, rutted roads and bolstering rickety bridges for use by Army traf- fic.

The battalion, which had two companies located in Torrance before its induction into fed- eral service last September, is in the midst of a rigorous unit training program along with other elements of Southern California's 40th Infantry Division.

Board OK's Price Tag on Land for Kettler School

The Torrance Board of Edu- cation considered an asking price of \$20,000 for a six and a half-acre site for the pro- posed school to serve the Ket- tler Knolls area a "reasonable" one Tuesday night and direct- ed the county counsel to ne- gotiate for the purchase of the property.

The property is located at 235th street and Narbonne avenue. Owners of the prop- erty would retain the oil and mineral rights while the school district would acquire all sur- face rights to the land.

Instructor To Have Jury Trial

A jury trial on July 10 was set by Federal Judge Pierson M. Hall on Monday of this week to hear the case against Clar- ence H. Vetterli, El Camino Col- lege instructor, charged by the FBI with perjury before a Fed- eral Grand Jury.

Although Vetterli waived a jury trial Judge Pierson ex- pressed the opinion that the case should be heard by a jury. Earlier the college journal- ist instructor had entered a plea of guilty on one of the charges in the court of Federal Judge Wil- liam M. Byrne who refused to accept his plea and entered a not guilty plea for the 41-year- old instructor.

Vetterli, who lives at 17107 Crenshaw boulevard in North Torrance, is charged by the FBI with giving false testimony be- fore the grand jury two years ago during a Red espionage in- vestigation.

He is currently on voluntary leave from the college pending the outcome of the trial.

Token Pay Hikes Given to School Administrators

Token salary raises were voted Tuesday night by the Board of Education for the Superintendent of Schools and the Business Manager of the school district.

William H. Tolson moved that the Superintendent, Dr. J. H. Hull, be granted a \$200 per year increase and that Emmett In- gram, assistant superintendent and business manager, be given a \$300 increase.

"Actually," Tolson said, "it is far short of what they deserve."

Commenting on the increases, Judge John A. Shidler, president of the board, said:

Special Mass Set for Soldier Killed in Korea

A special Mass will be cele- brated in the Catholic Church of Nativity here Tuesday morning for Staff Sergeant Gordon Phil- lips Robinson, a former Torrance High School student who was killed in Korean action last Sep- tember.

The body of the 19-year-old soldier was returned to the United States last week, and will be buried in Fort Rosecrans Na- tional Cemetery in San Diego with full military honors Wed- nesday.

The son of Mrs. L. E. Phillips, formerly of 2016 1/2 Andro- ceo avenue, Robinson was killed in a big push against the North Ko- reans last September 12. He was serving with the 8th Cavalry Division at the time.

Military rites for the soldier will be held at the National cemetery in San Diego at 2:30 p.m. Wednesday, June 13, ac- cording to his mother. Orders for flowers should specify that they be sent directly to Ft. Rose- crans, Mrs. Phillips said.

Second Tot Dies After Tumble in Scalding Water

Second recent death of a small tot falling into scalding water was reported this week when 17-month-old Kathleen Dill fell into a bathtub of steaming water last Sunday evening.

The accident occurred when the baby tumbled into a tub of hot water her mother, Mrs. Jackie Dill, had drawn in the bathroom, investigators said. The Dill home is at 1636 West 203rd street.

It was on April 1 that 3-year- old Maria Rebecca Ornel fell into a bucket of scalding water at the home of her uncle, Ed- ward Parano, at 4380 West 182nd street. Little Maria suf- fered severe burns, but lived un- til April 26.

Funeral services for Kathleen were held yesterday in the Chapel of Chimes at Inglewood Park Cemetery. Interment there followed the rites.

She leaves her parents, Mr. and Mrs. Ray B. Dill and a sis- ter, Linda Lee, at the home ad- dress. Stone and Myers Mortu- ary handled funeral arrange- ments.
