

### Driver Gets Jail Following Fatal Traffic Accident

Driver of a car involved in a fatal Harbor City accident which occurred last Sept. 13, was sentenced to serve a year in county jail following his recent conviction of manslaughter.

Chester E. Hayward, 43, of Venice, was found guilty following an accident at Pacific Coast Hwy. and Western Ave. in which James M. Miller, 29, Harbor Hills, was killed.

Hayward, who received a broken neck in the accident, appeared for sentence wearing a neck brace. His application for probation was denied by Judge Fred Miller in Long Beach Superior Court.

A jury found Hayward guilty of the charge.

### Thief Walks In; Walks Out

A burglar who walked in the front door walked out again—carrying more than \$200 worth of rings, cuff links, necklaces and other jewelry items, George H. Randolph, 2143 Pacific Coast Hwy., told deputies Monday night.

Randolph said he and his wife went out for dinner and found the articles were gone when they returned, according to Deputies E. J. Snyder and J. S. McAtee. The door had not been locked.

### Court Upholds Homeowners In School Row

The right of the Art Jury of the Hollywood Riviera Community Association to pass on proposed building in the area in keeping with deed restrictions was upheld Tuesday by Superior Court Judge David Coleman.

Judge Coleman gave the association and the South Bay Christian School 90 days to agree on changes in the school's design to make it conform with the architectural restrictions set up by the Art Jury.

The decision came after several delays in a suit brought by the community association against Albert Trier, principal of the school, in an effort to force Trier to conform with deed restrictions of the community.

The association—which represents all of the property owners in Hollywood Riviera—has maintained that Trier has depreciated the property values in the area by constructing a one-story, concrete block schoolhouse on Pacific Coast Hwy. near El Retiro Park.

Gibson, Dunn and Crutcher, attorneys for the association, told the court that Trier did not obtain approval of his South Bay Christian School from the art jury in the area before starting construction. The association jury consists of an architect, a builder and a businessman.

Judge Coleman told the association and Trier that if they could not agree on what changes should be made to conform to his order within the 90-day limit, each was to submit a proposal to the court and the court would select the best proposal.

Residents of Hollywood Riviera have protested the construction of the school from the very start, and have stated that if the school were allowed to remain in its present form, property values of the area would be threatened seriously.

"Had the court decision been against the association, homes as small as 750 square feet could be constructed adjacent to homes now valued at \$15,25,000," one resident told the Herald.

### Boost in Use Of Colorado Water Foreseen

Demands for Colorado River water may be increased ten times if recommendations of the "Report of Referees" handed recently to the Superior Court are adopted and enforced, Carl Fossette, manager of the West Basin, said yesterday.

The referee in the case recommended that pumping in the West Basin be curtailed by 65 per cent to halt the intrusion of sea water into the basin. Deliveries of Colorado River water through the Metropolitan Water District and the West Basin now amount to about 5300 acre feet.

### Expect 1000 at Island Jr. Chamber Convention

More than 1000 members of California Junior Chambers of Commerce are expected to sail for Catalina Island when the State Junior CC Convention is held May 8 through 11, it was reported yesterday.

Sponsored by District 12, of which Torrance is a member, the convention will be held in and around the city of Avalon, acre feet a year. If the curtailment is adopted and enforced, the West Basin's present users would need about 19,000 acre feet of MWD water and demands of Los Angeles in the Wilmington area and the Dominguez area would boost the need to 50,000 acre feet.

A schedule of classes will be available early in May to give students a chance to plan their summer program.




