have driven cars more than 300 mph.
For the technically inclined here's what Don has done to his car to make it go like . . . it does!
He has installed a Wico Magneto and a Herbert roller tappet full race cam. The engine builds up a 10-1 compression ratio. Carburetion is furnished through Hilborn fuel injectors. The car rides (at Bonneville) on special Bonneville tires, 6.50 by 18's on the front and 7.50 by 18's on the rear wheels. The rear end is not locked because he had to tow it to the Utah salt flats.
His plans for the future include lowering the top even further than it is at present, streamlining the body, and lowering it. He hopes to beat his own record next year.

Group Shooting For New Scout Building Here
A committee representing several local service and civic groups met Thursday night to discuss plans for the construction of a multi-purpose Boy and Girl Scout building in Torrance according to William Walton at whose home, 1415 Aclasia Ave., the meeting was held.
Another meeting is slated to be held in two weeks. From this meeting it is hoped that a permanent building committee will be selected to function similarly to the one which supervised and sponsored the erection of the YWCA Building. At present many Scout activities in Torrance are conducted in a dilapidated wooden building on a portion of city-owned land at Plaza Del Amo and Carson St.
Attending the meeting were Hal B. Laudeman, area commissioner of the Boy Scouts, Mrs. Elizabeth Cowie and Mrs. A. C. Turner, representing the Girl Scouts; Sam Van Wagner of the Lions Club, T. G. Wilkes of the Kiwanis Club, and A. E. Thompson of the Rotary Club.
The cooperation in the undertaking will be sought from any and all local organizations, Walton stated.

Condition of Carson Boy, Hit By Car "Improved"
A Carson youth was reported to be showing slight improvement at Harbor General Hospital yesterday after he was struck by a car at Carson St. and Avalon Blvd. Thursday night. The boy, Gordon Randall, 11, at 616 E. Carson St., was taken to Harbor General Hospital suffering from a fractured skull, according to the California Highway Patrol.

Alert Police Recover 'Hot' Auto, Plates
Two alert Torrance police officers picked up a stolen car and a set of "hot" license plates during the early morning hours yesterday while patrolling Torrance Beach.
Officers Jack Hahn and Leo Gonzales spotted the wanted car parked among the trees south of Torrance Beach and staked out on the auto for more than an hour waiting for its occupants to return.
Failing to find anyone with the car, the officers impounded it.
Investigation showed that the plates had been stolen in Redondo Beach on Aug. 29 and the auto, a late model Mercury, had been stolen in Long Beach Sept. 5.

Robbery Victim Given 90 Days In County Jail
Sentenced to 90 days in jail with one day suspended Friday was Garry O'Brien, 19, who has been sought for questioning about the death of a 19-year-old youth in Hawthorne recently.
O'Brien was sentenced for violating a provision of the State Health and Safety Code pertaining to narcotics when he appeared in Inglewood Municipal Court Friday morning.
O'Brien had been the subject of an all-points search since Aug. 30 when Richard Rodriguez, 19, of 17518 Crenshaw Blvd., was found near death in Hawthorne. Rodriguez' death a short time later was first attributed to an overdose of heroin, but investigation into the actual cause of death is still being conducted by the coroner's office.
The suspect surrendered to his father in San Marino earlier this week and was turned over to sheriff's deputies.
Several days prior to the death of Rodriguez, O'Brien complained that two men, Malcolm Levinson, 18, and Berkeley Holt, 24, had "rolled" him while he was visiting his uncle's home at 808 Patronella Ave. here.
Shortly after the pair were picked up, O'Brien disappeared and had been the subject of a police search until his surrender last week. No charges have yet been filed in the Rodriguez death.
Levinson and Holt were turned over to the Long Beach Police Department to answer narcotics and robbery charges there.

Phony Ulster Gazettes Back

connection with the quarter-century memorial of the death of Washington. Again in 1850 as a half-century commemoration, further reprints appeared and from then on the Ulster County Gazette of the 1800 date grew into big business.
"Between 1857 and 1867 mail-order printers sent out posters to advertise their copies as "patriotic souvenirs" and promised that "even the blots and blurs of the printer are preserved." Prices were 10 cents each, 15 for \$1, 100 for \$5, all postpaid. The agents were McNally & Co., Chicago, and Charles Lyman Allen, 112 School St., Boston.
"The greatest boost to Gazette circulation was from the Centennial Exposition at Philadelphia in 1876. One printing firm had the contract for supplying the copies and they were sold on the exposition grounds by the armful at a dime each. Door-to-door agents later peddled them, and one edition, taken from stereotyped plates, sold 100,000 copies. In the early 1880s the plates were offered for sale through an ad in Printer's Ink and passed to the hands of a Washington curio dealer.
"That, however, wasn't the last of the Gazettes. Between 1888 and 1900 a Frederick (Md.) printer kept the type standing on galleys to fill regular orders in 10,000 lots for a pitman who traveled the fairs in the Eastern States. As recently as 1906 a shop in Decatur, Ill., was printing Gazettes in quantity lots.
"Altogether it is estimated that 1,000,000 spurious copies of the Washington funeral paper in 75 different versions have been produced. Text throughout is largely the same, but typography and pulp paper, varying with each edition, show them to be phony. When the first genuine copy turned up in 1930 the rag paper bearing a watermark tallying with existing copies of the Gazette of another date proved the authenticity.
"Evidence is lacking that reprints were sold as anything but children and great-grandchildren of the paper, yellow and dog-eared, from an old trunk that the memento took on supposed genuineness.
"All sorts of yarns sprang up about the discoveries. Families imagined that the Gazettes had been in their possession since the early days of the last century. Fancy went so far that the whole series of transfers from great grandpa to Aunt Hattie to mother were outlined. We've known Gazette owners to describe how their forebears came to the Midwest from upstate New York, then to California, each generation passing on the ragged heirloom that had been prized 100 years.
"Many a newspaperman has created bitterness when obliged to tell an earnest possessor that the paper he assumed to be valuable was not an original. Among the most distressed was an elderly gentleman who, when we ventured a doubt about his Gazette, demanded that we phone the Huntington Library. The curator then related the paper's history and the man was crushed. He seldom spoke to us on the street after that and our part in adding to his disillusion was held as a personal affront to his dying day.
"Some libraries have circular letters prepared to answer the inquiries sure to come every February. The Library of Congress sends out a special bulletin to present the facts to hopefuls. As long as Washington's Birthday is observed there will probably be people discovering Ulster County Gazettes and regularly will they be dejected upon learning that theirs is only a reprint."

Two Allied Gardens neighbors blew the whistle on a third Friday morning when they told police that the neighbor was using their yards as a dumping ground for her garbage and trash.
One neighbor complained that the garbage was piling up along her back fence and that "the maggots are running rampant as a result."
The other complained that the "garbage and refuse being thrown into the yard creates a definite health hazard, not to mention an affront to the olfactory and aesthetic sense of myself and neighbors."
Police visited the offender who promised to seek some other method of disposing of garbage and trash in the future.
