ORDINANCE NO. 1221
AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF TORRANCE, CALIFORNIA, ADOPTING A PLAN OF RECLASSIFICATION OF CERTAIN PROPERTY DESCRIBED IN PLANNING COMMISSION CASE NO. 650.

SECTION 1
That the City Council of the City of Torrance does hereby find and determine that the Change of Zone specified for in Planning Commission Case No. 650, as more particularly described in Section 3 hereof, is necessary for the protection and enjoyment of substantial property rights of the owners of property in the vicinity thereof; that said Change of Zone will not be materially detrimental to the public welfare or to the property in the vicinity thereof; that notice has been given, as required by Appendix 1 of the Code of the City of Torrance, 1954; that opportunity has been afforded to interested parties as therein provided to protest the proposed Change of Zone before the Planning Commission and the City Council of the City of Torrance; and that Hearings on the application have been held as therein provided.
