State to Begin Rehabilitation Of Addicts at Chino This Fall

The State of California will start a program for non-aggressive narcotic addicts this year at the State Institution for Men at Chino.

Non-aggressive narcotic addicts are those who have not been convicted of any crimes except narcotic addiction. About 150 addicts will be taken into the institution at Chino in September or October, this year, for preliminary examination, and then sent to the branch of the same institution at Tehachapi, where they will receive the actual treatment which is hoped will cure them of narcotic addiction.

THE TEHACHAPI branch is only a temporary location, pending the construction of a combination hospital and prison, costing two million dollars and caring for 600 inmates, which should be completed at Chino by May, 1962.

Meanwhile, the State of California is attempting to persuade the Navy to release a former naval hospital in Riverside County which the state could use for a permanent rehabilitation center.

GOVERNOR BROWN has appointed Roland W. Brown, who has been deputy superintendent of the California Men's Colony at Los Padres, as supervisor of the new narcotic rehabilitation program, but his appointment must be confirmed by the California State Senate at the next session of the Legislature.

The establishment of the state center for rehabilitating narcotic addicts is supposed to take care of non-aggressive narcotic addicts who can be committed by judges for a term of five to ten years, depending on whether they are convicted of a misdemeanor or a felony, but such commitment is at the discretion of the judge. If he does not believe they can be rehabilitated, they are sent to jail or to prison.

UNDER NEW laws, narcotic addicts can be paroled to the California State Adult Authority after six months of satisfactory progress under the rehabilitation program, but this requires the recommendation of the director of the State Department of Corrections. An addict thus paroled to the Adult Authority would be under strict supervision, including periodic and surprise tests, such as the Nalline Test, established by a law of which he was the author. If the addict returns to narcotics, he can be sent back to the rehabilitation center at once. The new law also provides

for "half-way houses" in metropolitan areas, such as Los Angeles, where the addict stays while he becomes adjusted to normal life, and is under constant observation.

HAVING BEEN paroled, if the parolee does not use narcotics for three years after his parole, the court can dismiss the original charge and discharge him from the rehabilitation program. If the addict does not abstain from drugs, he can be sentenced to prison even after the treatment is supposedly completed.

I voted for this new rehabilitation program in the hope that it will work, but I have mental reservations about it in the case of heroin addicts because heroin causes the addict to lose all desire to reform or become rehabilitated. Heroin kills all conscience, moral sense, and judgment. Statistics indicate that only a very small percentage of heroin addicts are ever rehabilitated under any program, including that conducted by the United States at the federal hospitals specializing in this treatment.

THIS IS ONE of the reasons why I introduced a tough bill regarding the introduction and admissibility of evidence in narcotic cases. We did enact a tough penalty law, but penalties mean, nothing without convictions, and convictions are not obtained without evidence.

The governor and his leaders in both the Assembly and the Senate were violently opposed to my evidence bill, two similar evidence bills introduced by other members of the Assembly, and similar bills introduced in the Senate. My bill and the other bills were killed in committees.

I TRIED to get enough votes on the floor of the Assembly to take my bill out of committee by an Assembly vote, but most of the Democrats, and some of the Republicans were opposed to a tough evidence bill, not because of personal convictions but because they wanted to please the governor and his floor leaders.

That is the story for now. I shall keep fighting!
