Volunteer workers are needed now to assist in community health programs, hospital service, and in preparing the annual Christmas Seal Campaign mail by the Tuberculosis and Health Assn. of Los Angeles County.

Mrs. Harold Tegart, chairman of the Christmas Seal Assn.'s volunteer services advisory committee, said that names are now being added to the volunteer register of the organization aid that help is needed in many areas of program activity.

Association volunteers serve in community chest X-ray programs, assist in research projects, visit patients on chest illness wards of hospitals, and work at association headquarters preparing the annual Christmas Seal mailing, she said.

Chest X-ray Date Listed By College

A mobile X-ray unit, privately owned, and operated by California Chest Surveys, will be on the campus of E Camino College Wednesday, Sept. 20, from 9 a.m. to 3 p.m. and 6 p.m. to 9 p.m.

Employees of the college, in meeting the requirements of the Board of Trustees, are required to submit to a chest examination on an annual basis.

"Students and residents of the community are welcome to avail themselves of the opportunity of having an X-ray made locally at a cost of \$1," Polly Butts, college nurse, said.

The X-rays are taken by a licensed X-ray technician and are interpreted by P. K. Telford, M. D., chest specialist, who was head of the Tuberculosis Division of the L.A. County Health Department for 25 years.
