

Andrews Named First Team End On Metro Squad

Mike Andrews, former South High All-Bay League end, now enrolled at El Camino, has been selected to the first string All-Metropolitan Conference grid squad at the flanker position.

Andrews, at 6-2 and 177 pounds, playing his first year in the Tribe's fourth place finish in the rugged Metro Conference. He finished fourth in scoring for the loop, hauling in seven touchdown passes and snagging three, two-point conversions for 48 points.

HARBOR COLLEGE also placed a man on the mythical eleven. Mike Ferragamo, 5-9, 190-pound middle guard from Banning, was selected for his heroics in helping the Seahawks to their finest season in years.

On the honorable mention list, ECC placed four men while two Seahawks received the honor.

Kurt Altenber, 6-2, 190 pounds at end; tackles Tom Fitzgerald, 6-1, 185 pounds, and 6-1, 240-pounder Jim Miller, as well as quarterback John Torok, 6-1, 185 pounds, were given honorable mention.

From Harbor, 6-1, 230-pound tackle Dave Edwards and San Wicks, 5-10, 191-pound back, were awarded honorable mention.

John Reynolds raced 42 yards for the first score of the game to set the stage for the Torrance Vikings 33-0 win over the Hawthorne Scorpions in a Pop Warner contest.

The Vikings took advantage of long runs to post the victory. George Ray scored on an 18-yard jaunt and Jack Hase grabbed a Scorpion fumble and raced 30 yards for a TD. Dan Pritchard tackled on another tally when he hauled in a Reynolds' pass for a score. The other Vike points came when Skip Hogue tackled Gary Beard behind the Hawthorne goal for a safety. Sole conversion of the game came on a Pritchard boot.

IN ANOTHER tilt sparked by long runs, the Torrance Oilers fell before the Baldwin Park peewee squad, 26 to 13. Gary Biddle scored the first Oiler touchdown on a 20-yard carry-over tackle and Tony Walchler skirted end for 50 yards and the second Torrance six-point-er. Steve Smith grabbed a pass from Gary Biddle for the conversion.

The Hawthorne Wasps defeated the Torrance Chargers 20 to 6 in another engagement. Terry Tiedeman scored the only TD on a 1-yard plunge.

In the only other tilt, the Torrance Steelers were shut out by Canoga Park Middlets.
