Nine Torrance Schools Present Music Festival

Nine elementary schools in the North Torrance Area and North High School will present a varied music program of band and orchestra Friday night, April 13, 7:30 p.m., in the North High School gymnasium. The program will include a variety of dances, marches, folk songs, and symphonic works, representing the versatility, the educational and cultural growth of Torrance children.

A considerable amount of teacher directed group and individual practice has been conducted in order that students could develop the responsibility, consistent work habits, and teamwork required in the musical production. The values realized in self-satisfaction and musical understanding on the part of students is borne out by the fact that even though the music period is relatively short, many children beg to remain and continue the practice at the end of the day.

Schools and music directors taking part in the Northern festival are as follows: North High, Bob Jones; Perry, Crenshaw, Madison—Ronald Blank; Edison, Hamilton, Yukon—Adrian Paskowitz; Lincoln, Casimir, Carr—Milton Marcus. During the program school board member William C. Boswell will introduce the music teachers, who have studied and played professionally in this and in foreign countries, in colleges and universities, including Juilliard, New York, Notre Dame, Illinois, Tel Aviv, USC and UCLA.

Members of this group have as a professional background a number of engagements including work in the New York Philharmonic, Hit Parade, radio, TV, motion pictures, Los Angeles Philharmonic and Beach Cities, Compton and Pasadena community groups.
