Between 800 and 1000 members of the California State Division, American Association of University Women, are expected to attend the 41st Annual Convention at the El Dorado Hotel, Sacramento, May 17, 18 and 19. Eight delegates from the Palos Verdes-Rolling Hills branch are planning to drive up for the three day session. They are Mmes. Harold Simar, branch president, D. F. Dyrsmid, Robert S. Fraser, Frank Fisher, Joseph Goodwin, H. C. McLendon, Raymond Oddone, and Harry G. Peterson. The theme of the convention will be "The AAUW Member in the World of Today," and the keynote speech will be given by State Division president, Mrs. Neville T. Massa, whose topic will be "Challenges: Our Opportunities." "Challenges may be just the opportunities and the inspiration the educated woman needs to focus her abilities and channel her energies into community and world betterment," asserts Mrs. Massa. Dr. Margaret Claire Cross, AAUW International Fellow from England who holds her Ph.D from Girton College, Cambridge, and is now working at Huntington Library on a revision of her doctoral thesis, will be the speaker for dinner Thursday evening. Her topic is "Comparative Education in England and the U.S." After dinner, roundtables will be held in fellowships, finance, arts, and public relations. Two outstanding speakers will address the convention delegates. Dr. Anna L. Rose Hawks, AAUW national president, will speak at the Friday night installation dinner. An educator of note, Dr. Hawks believes that women in today's world must perform many roles simultaneously — that of housewife, business woman, mother, and community leader. Her topic will be "The World and Our Purpose." She will bring to her talk a wide background, having served her country on the United States Advisory Commission on Educational Exchange, and the U.S. Commission for UNESCO. The convention will conclude with a fellowship luncheon at which Dr. George Hedley, chaplain of Mills College, will review his biography of Dr. Aurelia Henry Reinhardt, past national president of AAUW and for many years president of Mills College. Dr. Hedley's book is called "Aurelia Henry Reinhardt: Portrait of a Whole Woman." The nursery school is in operation four mornings per week from 9 a.m. to 11:30 a.m. during the school year. The morning session is a laboratory experience for mothers who participate once each week as assistants under the guidance of the professional teacher-director, Mrs. Alvin Kaye.

Mothers learn to work with children in a well-rounded nursery school program which includes out-

door equipment in a large fenced yard. A modern nursery school building also houses many interesting and educational materials.

Fathers and mothers both attend evening classes where a varied program of films, discussion groups and lectures by experts in child-study offers them a better understanding of their children and themselves.

Fathers spend three hours per month engaged in the construction and repair of the school equipment. The results are evident by the interesting materials on hand for the children's use.

The school, which is located at 4558 W. 182nd St., Torrance, is attended by families from many parts of the area.
